Beef Co-products

Beef offal prices were generally softer with a steady dollar and supply remaining tight. Beef tongue and tail prices continued to perform well.



Head offal

Head meat averaged \$5.37/kg which was 47¢/kg higher year-on-year but 83¢/kg below last month. Cheek meat was \$2.62/kg dearer than year-ago levels, averaging \$9.60/kg, to be \$1.15/kg firmer month-on-month.

Lip export prices to the US and Mexico firmed 51¢/kg month-on-month, to average \$4.79/kg to be \$1.71/kg up on last year. Halal lips averaged \$5.03/kg to be \$1.77 firmer than October last year but 10¢/kg lower than last month.






Beef offal trends

Omasum eased 19¢/kg from last month, to average \$7.37/kg, up 52¢/kg from year-ago prices. Halal omasum averaged \$7.23/kg, up 36¢/kg year-on-year and 58¢/kg firmer, correcting the fall month-on month.

Halal tripe pieces averaged \$2.00/kg down \$1.55/kg year-on-year and 80¢/kg softer than last month. Nonhalal tripe pieces were 52¢/kg down year-on-year but 24¢/kg higher than September to average \$2.11/kg. Honeycomb tripe averaged \$7.17/kg to be 9¢/kg above year ago prices but 18¢/kg down on last month.





Beef offal trends continued...

Aorta firmed to average \$9.82/kg up 72¢/kg month-on-month and \$2.29 above the October 2020 price.

Heart prices were up from last month, averaging \$3.64/kg, to be 83¢/kg above year-ago levels and 34¢/kg above September price. Halal hearts averaged \$3.61/kg, firming 17¢/kg month-on-month and up 53¢/kg from October 2020.



Kidneys were not reported for the month.

Non-halal lungs averaged \$2.51/kg up 74¢/kg from year ago levels but 65¢/kg down month-on-month, while halal lungs averaged \$3.99/kg, up \$1.47/kg year-on-year but 69¢/kg cheaper than last month.




Figure 4: Trends in beef offal prices

Beef offal trends continued...

Liver prices averaged \$1.70/kg, up 55¢/kg month-on-month and 41¢/kg firmer than year-ago levels. Halal livers were weakerer by 24¢/kg over last month's price to average \$1.89/kg, up 41¢/kg on last year prices.



Japanese and Korean Offals

Tongue prices were \$4.68/kg up from September to average \$29.40/kg and were \$19.47/kg above year-ago levels.

Thick skirt was \$1.27/kg higher year-on-year and 85¢/kg firmer than last month, averaging \$10.00/kg. Thin skirt averaged \$10.05/kg, up 90¢/kg from September and \$1,36/kg above year-ago prices.

Rumen pillars eased with heavy weight product averaging \$13.50/kg, down \$1.91/kg month-on-month but \$4.93/kg higher than October 2020 levels.





Figure 6: Trends in Japanese offal prices

Tails and Tendons

Tail prices to USA firmed \$1.41/kg from last month, averaging \$18.90/kg, to be \$8.04/kg above year-ago levels. Halal tails averaged \$18.36/kg, down 77¢/kg from last month but \$7.76/kg above year-ago prices. Tendons averaged \$9.50/kg to be \$2.27/kg above October 2020 price and \$1.40/kg up on last month.



Sheep Co-products

Sheep offal prices were firmer with kidneys going against the trend.

Sheep offal

Sheep hearts averaged \$4.38/kg, up 14¢/kg month-on-month but 53¢/kg dearer than year-ago levels. Sheep kidneys were reported at \$6.05/kg which was 56¢/kg below September price. Sheep liver averaged \$2.08/kg to be 93¢/kg firmer month-on-month and 23¢/kg higher than October 2020.

Sheep tripe averaged \$5.10/kg, which is 30¢/kg weaker compared to year ago prices but up 17¢/kg month-onmonth. Long cut tongues were not reported.




Figure 8: Trends in sheep offal prices

Lamb runners averaged \$6.70/piece firming \$1.82/piece year-on-year and 18¢/piece up from September while sheep runners were reported at \$5.63/piece, up 23¢/piece month-on-month and up \$1.88/piece from September 2020.



Figure 9: Trends in runner prices





The average foetal calf blood has firmed \$72.50/litre year-on-year to average \$522.50/litre which is down \$62.50/litre month-on-month. However supply contract expiry times affected the price with the current purchase price at \$585/litre.





Concentrated gall averaged 24.50 to be 3.00 (kg up on October 2020 price but 50 (kg down month-on-month...





Rendered products

Rendered products remained firm across the board this month with tallow leading the way on strong demand on the back of reduced production.

The price for 50% protein MBM eased \$4/tonne from last month, averaging \$736/tonne which was \$61/tonne above October 2020 levels. Blood meal averaged \$1154/tonne, up \$224/tonne compared with last year's price, and \$144/tonne firmer month-on-month.

Tallow prices were again remained very firm, with the price for 1% FFA tallow averaging \$2063/tonne, up \$1070/tonne from October 2020 but \$27/tonne below last month prices.

Hides

The hide market continued the recent downward trend during the month with traders reporting further price reductions going forward. Difficulties in getting shipping containers and steep increases in freight costs continue to exacerbate the situation whilst demand has continued to fall, driving leather prices lower

Local prices for hides were softer with prices for better quality product down \$4.00 to \$6.00 per piece monthon-month on the heavier end.




Figure 13: Trends in hide prices (East Coast Ex Works)
