INFORMATION FOR APPLICANTS

Eligibility

To be eligible as a member of Meat & Livestock Australia Limited ABN 39 081 678 364 (MLA), the applicant must:

- be a *Producer*; and
- pay *Levies* during the financial year in which an application for membership is made, or paid *Levies* during either or both of the two preceding financial years.

Producer means a person engaged in the raising, finishing or trading of livestock for production or for live export and includes a producer of cattle*, grainfed cattle*, sheep (including lambs) and goats.

***cattle** means bovine animals other than buffaloes and includes calves but excludes grainfed cattle;

***grainfed cattle** means grainfed cattle that are eligible for GF or GFYG certification or third party audited certification approved by AUS-MEAT attesting that cattle are being fed to at least the AUS-MEAT minimum standards for grainfed beef.

Levies means levies or charges imposed on producers of livestock under the following Acts:

- the *Primary Industries (Customs) Charges Act 1999*; and
- the *Primary Industries (Excise) Levies Act 1999*.
