2 Background

This project has built on the experience gained and the processes developed in 2006/7 when the Environment Managers network was first established. This is a state based network of researchers, regulators, trainers and practitioners which mirrors the Training and QA Managers Networks. This year the network moved to expand the involvement of the regulators and industry peak bodies such as AMIC and expand the opportunities for environment managers, researchers and regulators to use the network as forum to explain, explore and discuss new issues and innovations.

This network is still in its infancy but is already well supported by industry bodies, the State and Federal regulators and a growing number of processors. This is leading to some valuable networking and some ideas for the future directions we need to take make the network self sustaining. In this its second year a greater level of maturity in the networks interaction with the regulators has been experienced and greater benefits derived for both industry and the research agencies.

The two main functions of the network are to:

- organise network meetings in every mainland State twice a year involving interaction between the processors and researchers, AMIC, state and federal regulators, technical experts and technology suppliers.
- professional development workshops delivered in selected regional centres aimed at meeting training and professional development need identified by industry.

3.2 Milestone requirement 2 – summary of stakeholder consultation and involvement in networks

The project has made considerable progress in attracting industry participation and just as importantly we are making real traction with the regulatory and industry bodies. AMIC is now fully engaged with the network and every single State Department of Environment or equivalent has had speakers and participants at network meetings.

However industry participation is still on occasions patchy and we struggle to get this industry engagement but the progress this year has been very encouraging. By this time next year we should have this environment managers' network functioning as well as the other two networks. In addition to the main target audience or participants a range of other organisations are keen to establish communication channels with the industry. These include:

- industry consultants
- municipal governments
- non slaughtering establishments such as tallow processors

Commonwealth Government bodies such as the Australian Greenhouse Office and the National Pollution Inventory.

The training that was identified by the networks and set up in each State has been well patronised and we are hopeful of another big training year in 2008/9.

3.3 Milestone requirement 3 - summary of issues raised, initiatives and outcomes of the network for year

Water Re-use

The need for water use reduction and reuse strategies still continues to be an issue for most parts of Australia with the seven year drought continuing abated in many regions.

The roll out of the finalised AQIS notice on water re-use and the release of the results of the MLA water re-use research project will be one of the networks main initiatives early in the new financial year.

Changes in reporting procedures

Most of the State EPAs or equivalent authorities have introduced new reporting requirements for water and energy use. The network has worked hard to engage these authorities to explain the changes at the network meetings. Likewise the National Pollution Inventory has also changed its reporting requirements and expanded those who are required to report.

3.4 Milestone requirement 4 - recommendations for the coming year

MINTRAC is going to have to concentrate on a range of initiatives to further energise the network.

- 1. Launch a specific campaign to engage the environment managers in each processing plant on a person to person to identify
 - technical and regulatory issues that are of paramount importance
 - the form and content for future workshops that will help them expand their technical expertise and competency in handling current issues
 - types of technology that they need to know more about.
- 2. Engage AMIC and the regulators in identifying topics of importance well in advance.
- 3. Integrating into and becoming a extension of the AMPC's environment committee planning and the resultant MLA research projects.

MINTRAC Environment Manager Network Meeting, WA

Note: The minutes record items in the order they are listed on the Agenda. Some items were addressed out of order during the meeting.

Matters arising from previous meetings

- Interpreting water testing results
- Funds for waste water management training
- Guidelines for water quality for irrigation A meeting to be set up meeting for further discussion/negotiation with the key players. Arose from an amendment to the water quality notice which was amended without consultation with industry – put in place a 30 day withholding period –discrepancy with federal notice and apparently not supported by scientific evidence.

Training for industry environment personnel

- Waste Water Management Certificate II available a plant site is required to host the course, and 6-10 participants needed. Some east based plants requested a combination course with level III. Run in two blocks x 4 days plus assignments, workplace projects etc. Need to advertise the course content for both Certificate II and III. Would like to start beginning of September. Cost will be about \$1,000 \$1500 per person.
- Other requests:
 - Composting workshop considerable interest

Water audits

(Presentation by Dr Tony Farrugia, this presentation is available on the MINTRAC website) Discussion points which arose during the presentation:

- Offal transport alternative systems; what are the options?
- Reduce nozzle sizes on hoses.
- MINTRAC is looking for a company willing to provide training to cleaners in water awareness; need to have capacity to measure water consultation before and after.
- Membrane systems anyone in meat industry using? Poultry industry Inghams is using one.
- Financial return on waste water re-use systems? Big variations, depending on systems; often big up-front capital cost driver is usually legislation.

The Department of the Environment and Conservation and the meat processing sector (Presentation by Paul Byrnes and Nanette Schapel, this presentation is available on the MINTRAC website)

Discussion points which arose during the presentation:

- The meat industry needs to do some long term planning to ensure environmental sustainability; DEC looking very closely at meat industry applications
- Annual Audit Compliance Report: (AACR) now in place (April 2008) allows plant
 to improve self-monitoring; will be placed on website; to be submitted with annual
 environment monitoring reports; is available on DEC website www.dec.wa.gov.au
- Process for seeking an amendment to monitoring and reporting requirements?
 (e.g. required to take samples from a brook, but not always running) Is proponent instigated 21 day letter fairly simple processes through local branch of DEC.

- AACR duplicating the conditions of the license? Not really, but cover page is key component.
- Participants encouraged to phone up and discuss issues DEC is using an open approach.

Update on emissions trading, who will be liable parties under the National Greenhouse and Energy Reporting legislation

(Presentation by David Liversidge, this presentation is available on the MINTRAC website) Discussion points which arose during the presentation:

- System of national 'gateways' to be in place; penalty will be a requirement to purchase offsets; scheme will start in 2010.
- Every meat industry company has capacity to reduce emissions.
- Rudd government likely to set firm targets.
- Opportunity to reduce costs through offsets.
- Challenge is how to calculate emissions?
- Green paper due out 1 July 2008 possible to make comments on this www.climatechange.gov.au (go to media releases)
- Government aim is to not disadvantage industry or companies.
- Online OSCAR reporting will be sued.
- National Pollution Inventory? to be listed as an agenda item for next meeting.

Draft AQIS Notice on water reuse and the state water reuse meetings

Copies of the draft notice were distributed. This is also on the MINTRAC website.

- Not sure how long before this becomes official.
- AMIC putting it out through state consultative process and will give feedback to AQIS.
- Chaney feedback is to be provided to AMIC.
- Draft finalised goes to EMIAC and will then be placed on website.
- Aim is to facilitate industry's needs in relation to water re-use.
- As projects are approved it will go onto either MINTRAC, AMIC or MLA website (except were there are commercial-in-confidence issues)
- MINTRAC will be running workshops on projects that work.

Greenhouse Challenge Plus program

(Presentation by David Liversidge, this presentation is available on the MINTRAC website)

Discussion points which arose during the presentation:

- What are noxious gases apart from CO2? methane, laughing gas, N2O, synthetic gases (refrigeration)
- The key thing about climate change is the rate of change.
- Australian Greenhouse Office has been spilt into several new departments
- There is a template available for companies to work out what carbon footprint is done under ABN to prevent double-counting.
- Newsletters and CDs about the program were handed out to attendees
- If liable have to register by 1 July (liable? See slide) Probably only impacts larger meat companies.
- Timelines are in 17th March media release. Green paper is next.
- Best way of leaning is getting involved in program.
- Young methane project still on trial? Yes is flaring regularly and has solved odour row with town; visitation planned for August – attendees welcome.
