- timely and comprehensive dissemination of research and development outcomes to appropriate industry personnel
- the uptake and integration of key research and development outcomes in industry
- integration of research and development outcomes into the industry's accredited training system
- the ongoing availability and provision of timely and accurate advice to industry personnel.

### 1 Background

The Extension Services contract formalises the partnership between the two RDCs (AMPC and MLA) and MINTRAC to perform dedicated and defined extension activities.

Extension activities under this agreement constitute:

- projects, [that may constitute applied research/review activities, or relate to the education, communication or extension of such research activities]
- material development e.g. educational material, tools, resources, e-learning materials, brochures/booklets, fact-sheets, reviews, reports, presentations, workshops or other similar activity to be developed for purposes of wide dissemination to the red meat industry
- education and training activities, [where these relate directly to funded R&D, past or present, within MLA and AMPC respective portfolios]
- market research, such as industry surveys, interviews, data capture and other communication or community engagement exercises (which are captured formally under the agreement as "projects")
- data reporting and maintenance of contact databases within MINTRAC for dissemination of information to industry
- industry extension activities including workshops and presentations, of which the current MINTRAC networks are included.

MINTRAC will undertake the following consultation, extension and technical advice activities.

#### 1.1 Section 1: General training-related activities

- 1.1.1 Industry representation on education and training matters e.g. AgriFood and state agencies.
  - participate in relevant forums and identify issues relating to training and extension services for the meat industry that require further scoping and RD&E
  - ensure appropriate representation of the meat industry in the design and development of accredited training e.g. definition of Skill Sets, approval and equivalence of training,
  - recognition of skills that comprise meat industry jobs, ensuring acceptance of training programs and units on the national scene
  - respond to relevant submissions on national VET framework and associated policies on behalf of the meat industry
  - provide reports on changes to policies and the educational framework to relevant industry bodies e.g. AMPC, MLA and AMIC.
- 1.1.2 Development of materials and delivery of career advice towards attracting and retaining personnel in the meat industry
  - develop and provide materials, support, consultation, information to all people of all levels, answering enquiries etc
  - identify, assess and coordinate opportunities for career advice/materials to be provided and extended within relevant industry and/or Government/stakeholder forums to the wider community
  - develop and refresh over time, materials to support and attract new personnel to the meat industry in relevant careers.

- 1.1.3 Management of the meat industry training package and educational materials
  - maintain the continuous improvement register for the Australian Meat Industry Training Package to ensure that innovations, new science and changed regulations are incorporated in a timely manner
  - develop new Units of Competency as required by industry
  - undertake a quarterly scan of imported units to identify changes and opportunities for continual improvement
  - receive, address and maintain a register of training package enquiries
  - make changes/revise training package as directed by AgriFood and in consultation with industry
  - maintain current training and assessment support materials.
- 1.1.4 Identification of requirements in industry that need to be integrated, developed and formalised within the current training framework/system
  - work with the Principal to identify new areas that require underpinning skill base and associated training materials e.g. livestock handling, traceability, meat science
  - develop associated training, assessment and support materials
  - develop training tools e.g. kits and e-Learning materials.
- 1.1.5 Identification and promotion of training opportunities and funding channels to support company adaptation and adoption
  - publish and communicate new training and funding opportunities in MINTRACKER and via the MINTRAC networks
  - promote new training and funding opportunities to meat processing companies directly through regular interaction with training managers.
- 1.1.6 Professional development services
  - conduct surveys at least twice yearly to identify industry professional development requirements
  - identify suitable accredited training wherever possible
  - source available state funding to support provision of programs where available
  - source suitable providers to deliver training program.

#### 1.2 Section 2: General Extension Services

- 1.2.1 Consultation, extension and advice provision/information services
  - provide direct support to levy paying companies
  - support companies that require training information, materials and advice
  - provide a reliable service that is available to address the information needs of industry
  - keep a register/report of enquiries annually for purposes of joint review/acknowledgement towards continual improvement with the 3 parties
  - provide training and extension related advice, information services and industry support
  - provide Industry representation and consultation with state, national and other agencies in relation to extension, education and training projects and activities
  - undertake market research, reviews and information gathering to identify industry extension and training priorities on behalf of AMPC.

## 1.3 Section 3: Specific activities related to the MINTRAC Networks and other funded projects

#### MINTRAC will:

- participate in the AMPC consultation committee (Extension and Capability) to determine RD&E projects for extension/education and subsequent presentation to AMPC Board by AMPC management
- collect and analyse data to determine the success of the networks in meeting their objectives and providing such data/reports to the Principal relevant to activities listed in this agreement.

Over the period of 2012-13, MINTRAC completed the following:

- signed a Memorandum of Understanding with the Australian Skills Quality Agency
- was a member of an Australian Workforce Productivity Agency Food Industry Reference Group
- designed and developed further Skill Sets for inclusion into the MTM 11 Australian Meat Industry Training Package
- undertook industry consultation around the design and development of further Certificate
   III level qualifications
- commenced the development of new Units to cover value adding activities in boning rooms
- developed new Units of Competency associated with contracted RD&E projects in the areas such as animal welfare auditing and NLIS
- provided reports to network meetings and conferences on changes to policies and the educational framework.

## 4.1.3 Delivery of career advice towards attracting and retaining personnel in the meat industry

During 2012-13, MINTRAC achieved the following:

- distributed careers materials to meat processing companies and schools on request
- commenced the development of a new careers promotional notebook

#### 4.1.4 Management of the meat industry training package and educational materials

Management of the *Australian Meat Industry Training Package* is mostly carried out under contract to AgriFood Skills Australia, although some development and extension work is covered by the Extension Services contract. During 2012-13, MINTRAC has achieved the following:

- maintained the continuous improvement register for the Australian Meat Industry Training Package to ensure that innovations, new science and changed regulations are incorporated in a timely manner
- developed new Units of Competency in the areas of NLIS, writing work instructions and SOPs, animal welfare auditing, packaging of meat products for commercial sale, value adding in boning rooms (commenced)
- developed new Skills Sets in the areas of waste water management and smallgoods for butchers
- undertaken a quarterly scan of imported units, identifying changes and opportunities for continual improvement which have been assessed against industry requirements
- received, addressed and maintained a register of Training Package enquiries, providing quarterly reports and recommendations to the Meat Standing Committee
- made changes to and revised the Training Package as directed by AgriFood and in consultation with industry, resulting in the release of versions 3 and 4
- maintained current training and assessment support materials by updating them to reflect the release of new versions, writing new materials where required, and updating the Unit by Unit listing on a quarterly basis.

- attended meetings of the MLA data link for stock heath project
- attended Sheep meat industry grass seeds committee meetings.

## 4.3 Section 3: Specific activities related to the MINTRAC Networks and other funded projects

### 5 Success in achieving objectives

## 5.1 Ensure timely and comprehensive dissemination of research and development outcomes to appropriate industry personnel

- the Environment, MI&QA and Training industry conferences
- release of a wide range of training and educational support materials
- the running of specialised industry workshops and tutorials
- daily interaction between MINTRAC staff and industry personnel.

## 5.2 Ensure the uptake and integration of key research and development outcomes in industry

This object has been achieved through:

- the incorporation of key research and development findings into the accredited training system
- the offering of professional development programs to training personnel to ensure they are fully conversant with current information
- the development of validation education and training resources
- thorough discussion of key research and development outcomes and their implications at network meetings.

# 6 Impact on meat and livestock industry – Now and in five years time

#### 6.1 Immediate impact

All of the activities undertaken under this contract, and in association with the contracts listed under 3.1, have the immediate impact of:

- ensuring that research and development outcomes are quickly and accurately embedded into the accredited training system and are therefore understood and applied by meat processing companies
- ensuring that industry trainers have current skills and knowledge
- providing a wide range of accessible reference and training resources and programs

- being comprehensively, consistently and systematically applied across the industry
- ensuring that expert training advice is readily accessible
- ensuring that the industry has fair and reasonable access to public training funds to address identified industry priorities
- ensuring that meat industry requirements are accurately reflected in public education and training policy
- ensuring that industry capability development occurs according to stated industry strategic directions.

#### 6.2 In five years' time

This Extension Services contract provides the industry with longer term confidence that there is a means of ensuring timely and comprehensive dissemination of research and development outcomes to appropriate industry personnel. Once these outcomes become part of the accredited training and assessment system the industry can have confidence that these initiatives will be ongoing and will continue to be addressed for as long as they are relevant to and of importance to the industry.

The MINTRAC quality assurance processes ensure that all industry-published materials are updated on a timely basis

#### 7 Conclusions and recommendations

This is the first time that the wide range of MINTRAC services and activities in relation to RD&E have been defined and captured in an overarching contract. This report has provided a comprehensive summary of the way in which R&D is extended throughout the meat processing industry and serves to illustrate the importance of capturing such activity in the accredited training system, and of ensuring that accessible, accurate advice is readily available to industry personnel.

No formal recommendations are made as part of this report as over the course of the year, the activities described in the report have already given rise to new project proposals and initiatives which are currently being discussed by AMPC and MLA.
