# executive summary

It is with a great deal of pleasure that Indigo Marketing & Communications submits to Meat and Livestock Australia the results of the 2007 Top 25 Processors research project.

### Methodology:

In undertaking this project we "short listed" 32 processors, that represented 59 plant sites. Each processor was contacted by telephone by way of introduction prior to emailing a survey regarding both their company details for updating and questionnaire regarding industry operating conditions, company and industry developments and request for their opinion on potential issues that were foreseeable in the short term (12 months).

In conjunction with our survey to the processors we undertook a thorough investigation of macro factors affecting the industry in order to provide context to the operational results for the top echelon of the industry.

### **Results:**

We were able to secure the responses of 23 processors.

There was some reluctance to provide figures from approximately one third of those that were surveyed. Further, approximately two thirds of those surveyed did not provide any financial information to us as part of the information gathering process.

Prior to the finalization of the report, we were advised that this project had been cancelled. The information included as part of this report is the total sum of information collected prior to the cancellation.

We would like to sincerely thank Meat & Livestock Australia for the opportunity to undertake this project on their behalf, and we look forward to working again with you in the future.

### **Processor Snapshot 2008:**

- National production figure of 2,827,570MT is 44,557MT less than 2007 results;
- Number 1 producer JBS Swift refused participating in this year's survey citing stakeholder interest;
- Nippon Meat Packers production has risen approximately 12% on 2007;
- Midfield Meats tonnage is back up to 2007 figures sitting at just under 75,000MT;
- The top 23 processors published represent 41 plant sites and 58.90% share of total kill.

### **Ranking Methodology:**

The Top 25 Processors has been published by feedback since 1999, with the omission of calendar year 2005.

This year, 32 companies were surveyed regarding their metric tonnage figures for the calendar year and company details regarding administration, operations, finance and marketing. The 23 respondents have been ranked determined on metric tonne figures. It should be noted that the data provided has not been independently audited, and the ranking has been based on information received by participating organisations.

The national kill share percentage is calculated as a percentage of national kill for all beef, veal, mutton and lamb, and is a figure provided by the Australian Bureau of Statistics.

### 2008 in Review:

### **Rationalisation:**

 JBS Swift purchases Tasman Group reportedly for \$150m in May 2008. The merger increases the JBS holding in Australia to 10 sites, employing 5,000 people with a capacity to slaughter 25,000 animals daily.

### **Emerging Markets:**

- The Brunei Government sets up a new company to supply Halal product globally, selecting Australian meat to supply this market.
- Austrade points to growing demand in the Philippines market predicated by forecasted population growth that will see the population nearly double in

- two decades combined with a growth in the food and fast food chain sectors.
- UAE continues to grow with the UAE beef market increasing 138% year-on-year and mutton increasing just over 25%.
- Russia's consumption of beef has increased from 5,000t to 67,000t in one year.

### Increased competition in traditional markets:

• US beef has begun to erode the safe markets of Korea and Japan with Abare citing a 23% decline imports of Australian beef to Korea during the four months June to September 2008 compared to the same period in 2007. Similarly Japanese beef imports are forecast to fall 6% during 2008-09.

### **Production Levels:**

- National herd numbers for cattle and sheep continue to decline throughout the 07/08 fiscal year.
- Cattle herd has declined 0.8% to 27.8m. A 4% increase in Queensland has
  offset the decline across the other states. Victorian numbers have dropped
  8% year-on-year and are now at their lowest level in 15 years.
- Australia's sheep flock has dropped 7.6% to 79.2m its lowest number since 1920.
- There has been a significant shift from sheep to cropping in WA that has seen numbers drop 13% year on year.

### **Drought:**

 Drought conditions continued across New South Wales, Victoria and South Australia.

### **Government:**

- DoHa Outcomes Proposed cuts to farm subsidy entitlements in the EU and US by 70-80%. Agriculture tariffs in the EU, US and Japan would be cut by up to 70%;
- Tariff quotas boosted to allow in some cases hundreds of thousands of tonnes of new market access in developed countries.
- ASEAN Australia-NZ FTA low tariffs on entry-into-force of the Agreement;
- Further FTA's under discussion with Japan, China and Korea;
- Tariff free exports to Chile negotiated from January 1 2009 Chile will recognize the AusMeat Industry Classification System;

### **Economy:**

- The depreciation of the Australian dollar amid the chaos of world financial markets from September onwards saw a reduction in the landed price of beef seeing a summary increase in US imports at the back end of 2008.
- The financial climate has seen an impact on consumers' demand for beef and lamb with consumption of less expensive beef cuts and ground meat products increasing particularly in the US and Japanese markets coupled with a 41% reduction in lamb exports to the US for the period July to September 2008 when compared to the same 2007 period.

Company Name Nippon Meat Packers Australia Pty Ltd

Nippon Meat Packers Australia (NMPA) was established in 1978 and is a wholly owned subsidiary of Nippon Meat Packers, Inc., Japan. A consistent top 25 performer, Nippon Meat Packers has grown its operation to a significant level in the Australian industry.

Nippon Meat Packers Australia produces a large range of beef products and by-products and exports to more than 34 countries. With its head office, sales and distribution centre (Beef Producers Australia) located in Sydney, NMPA employs over 1,650 people across 3 processing plants, 3 tanneries and feedlot.

The Oakey Abattoir located in Queensland was purchased in 1987 and is one of the largest chilled (mainly grain) beef processors to service the Japanese market, processing up to 1,200 head per day. The Wingham abattoir (NSW) specialises in British breed grain fed cattle and free range beef, processing up to 800 head per day. The Borthwicks processing site at Mackay was one of the first Australian production facilities to be certified for organic beef production and can process up to 700 head per day. Each site has an on-site rendering plant producing meat and bone meal, blood meal, bone chips, concentrated gall, beef bone extract and tallow.

<u>New Wave Leather</u>, a NMPA tannery operation, operates wet blue tanneries in Toowoomba (south east Queensland), Gunnedah (northern NSW) and Melbourne (Victoria), producing high quality wet blue leather and related products. New Wave Leathers processes approximately 50,000 hides per week for the export market.

Oakey Holdings operates the Whyalla cattle feedlot near Texas (southern Queensland), one of Australia's largest feedlots and a cattle breeding property Sheelite (King Island, Tasmania). Beef Producers Australia is the domestic distribution company for NMPA with depots in Sydney (NSW), Mackay and Cannonvale (central Queensland). Beef Producers Australia supplies a full range of both chilled and frozen beef, stocking most of our grass and grain fed brands including budget grass fed cuts to the higher export quality grain fed beef together with a select range of beef offals.

Primo Smallgoods is the largest producer of ham, bacon and smallgoods in Australia.

Primo's extensive infrastructure includes the operation of its own abattoirs - a beef plant in Scone NSW, and a pork processing plant in Port Wakefield, South Australia - as well as smallgoods manufacturing plants, a retail ready / portion control packing facility, and distribution warehouses.

The Primo Scone beef abattoir employs around 360 people, and is one of the largest employers in the Hunter region. The plant in situated in the Upper Hunter Valley which is recognized as one of the premier beef livestock regions in Australia.

The abattoir process in excess 3,200 head of beef per week on a single shift basis, and exports to most major markets around the world including Japan, Korea, USA, Canada, South East Asia and the Pacific Islands. It also holds exports licences for China and Russia which are other major export markets for the operation, and has plans to be Halal registered by 2010.

The plant processes mostly British breed livestock with a mixture of export steers, shortfed grainfed steers, and selected A\* beef for export markets. They also have a solid domestic business with retailers, wholesalers, and further processors, through their processing of grassfed and grainfed yearling cattle, as well as running a yearling MSA program.

In addition to the above operation Primo also have a pork abattoir in Pork Wakefield, South Australia. The pant has just been re-commissioned after an extensive rebuild.

The rebuilt plant now makes Primo Port Wakefield the most modern pork processing plant in Australia, incorporating state of the art technology such as robotics and carcass scanning. With a capacity to process up to 18,000 head per week it makes this facility the largest facility in South Australia.

The plant is also export registered and exports to various countries worldwide. Primo Port Wakefield has a reputation of supplying high quality pork due to its extensive work and long term commitment with local pork producers with regards to supply, specification and genetics.
