- Remember, you will need to use your myMLA login details and link your Livestock Production Assurance (LPA) account to be able to log in and pilot the platform.

#### Why the introductory webinar?

- The Environmental credentials for Australian grassfed beef platform has been designed to enable grassfed beef producers to measure and report on their environmental credentials and demonstrate their sustainability practices to markets and the supply chain. It is in the final stages of development before national release.
- The aim of the pilot webinar was to provide you with an understanding of the mechanics and abilities of the platform and the opportunities it provides to help producers demonstrate their sustainability practices.
- The important next step is for you to pilot the platform in your own time and test its ease of use, applicability, functionality, and the relevance of the content. By piloting the platform and providing feedback to MLA this helps identify refinements and improvements that may be required to ensure the platform is as relevant and useful as possible for producers.
