## 2 Schedule of fees

### 2.1 Payment of fees

To support the ongoing delivery and integrity of the MSA program to industry fees may be charged for work undertaken by the Authorised Authority.

### 2.2 Enterprise fees – beef

#### 2.2.1 Third party software developers

All MSA licensed third party software developers are required to pay a software access fee of \$5,000+GST, payable on execution of each third party software licence agreement, to gain access to the current version/s of the MSA beef and/or sheepmeat model.

#### 2.2.2 Technical services

Service fees will be charged to cover expenses incurred by the Authorised Authority when providing technical services to an Enterprise. MLA does not provide a commercial independent grading service.

Tax invoices, where necessary, will be issued monthly to the Enterprise, detailing all work undertaken and costs incurred. All accounts are payable within 30 days.
