Abstract

MLA supports innovation across the red meat sector by co-funding innovation managers for a term of 3 years. To improve the performance of these managers in their roles, MLA has contracted Hargraves Institute to develop innovation capability resources for the following four (4) topics:

- 1. **Innovation mindset** Includes what is innovation mindset? Why is it important? What are the steps and initiatives you can implement to create a culture of innovation in your business?
- 2. **Leading from behind** Includes what is leading from behind? Why leading from behind works, and how to successfully lead and motivate a project team in your business regardless of your position.
- 3. **Principles of project management** Includes define, plan, implement, monitor and evaluate as well as how to anticipate and reduce project risk.
- 4. **Presenting for approval** Includes the steps, practices and strategies to deliver your message effectively to maximise your chance of receiving approval regardless of your position.

These modules will be delivered in the online networking sessions with Co-Innovation Managers, and they will also be available as e-learning modules through the MLA e-learning portal.

1 Project description

Hargraves Institute worked closely with MLA to develop relevant learning modules using a combination of up-to-date research and experience from our extensive work with leading companies in Australia and internationally.

The learning modules address the needs identified in the Co-Innovation Program Final Report, 2020. These are:

- Innovation Mindset
- Leading from Behind
- Presenting for Approval (Pitching to Win)
- Project Management Principles.

They were delivered as part of the quarterly Co-Innovation Manager network sessions and refined in response to feedback.

The modules were also adapted and delivered as e-learning modules through MLA e-learning portals.

Co-Innovation Mangers will be directed to further resources to deepen their learning in the area if relevant.

2 Project objectives

Create, test and produce four (4) capability-building modules designed to help MLA Co-Innovation Managers succeed in their role.

The modules will:

- 1. Be specifically adapted for the MLA Co-Innovation program.
- 2. Be based on industry best practices, processes and content to define problems and pitfalls before outlining processes and frameworks that can be used to achieve the desired outcome.
- 3. Each module will be developed as a group presentation and a standalone resource that is intuitive and easy to self-navigate.
- 4. The provider must work with MLA to ensure the content meets MLA's requirements for elearning as set out in MLA's e-learning module creation template.
- 5. The provider must work with MLA to ensure the modules meet the MLA style and branding guidelines.

Each module will consist of the following;

- 1. A 1-hour PowerPoint workshop designed for group participation.
- A 1-hour self-taught web-based module that complies with MLA's e-learning module creation template and includes:
 - Introduction and summary of the problem and pitfalls
 - Practical frameworks and canvasses for group collaboration
 - Explanations of frameworks, where required
 - A summary page including the key processes and steps for each module
 - Self-assessment components
 - · Links to other resources and related content, and
 - Links to additional Hargraves Institute resources for advanced learning.

3 Milestone Six Objectives

- Develop and pilot the 'Pitching to Win' module at the face-to-face meeting in Queensland in June, 2022.
- Conduct the interactive session at the Co-Innovation Manager network meeting on 14-15 June, 2022.

3.1 Success in meeting the objectives

Leading from Behind, Innovation Mindset, Project Management and Pitching to Win modules were developed and delivered to the CoOlnnovation Network. They were aleso converted into e-learning modules for broader deliver to MLA and industry through the MLA e-learning portal. They can be accessed via the links below.


3.2 Next Steps


Q1: How valuable did you find the whole event?










Q6: Have you achieved your documented innovation objectives for the year? Answered: 10 Skipped: 5




Q8: Are any of these activities considered a first for industry?
