# **Purpose and background**

The close linkages between MLA's PDS program and GRDC's National Grower Network (NGN) in delivering impactful, on-farm, locally relevant projects created an opportunity to develop a partnership demonstration site program targeted towards mixed farming systems.

This partnership program will support groups of producers to demonstrate, adapt and validate the benefits of integrating new management practices, research and development outputs, and associated skills within the context of their commercial production systems.

The key outcome of the program is producer adoption of the demonstrated management practices, resulting in improved business performance.

Meat & Livestock Australia (MLA) & Grains Research & Development Corporation (GRDC) Producer Demonstration Site Program is offering a total pool of funding of up to \$ 2,160,000 over four years.

MLA and GRDC are calling for preliminary applications for PDS projects related to improving <u>mixed</u> farming enterprise business profitability and productivity that can commence during 2026.

# What is a PDS?

#### Proposals must:

Be initiated by a producer group and address a key adoption issue limiting farm productivity
and profitability, resulting in impact when adopted by producers. The practice or technology
being demonstrated should aim to enhance the synergies of livestock and grain production.

- Demonstrate the integration of new technologies or management practices, research and development outputs, and associated skills on a minimum of three different properties at a commercially relevant scale. Some flexibility is offered for projects in extensive regions.
- Consist of a core group of producers directly involved in the project with a larger network of producers (observers) keen to attend events/activities and receive communications to learn about outcomes.
- Core producers are responsible for much of the in-field activities (e.g. measurements, stock rotations etc.)
- Be based on known, scientifically proven practices and/or commercially available technology, i.e. not research on a problem/issue or proof of concept.
- Have a robust method designed to test an outcome, including untreated controls for comparison
- Have a suitably skilled facilitator to guide group activities, coordinate extension activities, implement protocols, and report back to MLA and GRDC.
- Include extension and communication activities to extend key messages and learnings beyond the core group. All projects will be required to develop a communication plan using the templates provided by MLA.
- Implement monitoring, evaluation and reporting (MER) processes to demonstrate producer
  engagement, practice change and the benefit to the production businesses and broader
  industry. All projects will be required to develop a MER plan using MLA's standard
  framework within one month of commencing, and support will be available to assist
  facilitators with development. A copy of the MER plan guidelines is available on the MLA
  website here.
- Submit a Data Management Plan (DMP):
  - The initial DMP is about establishing how data will be handled and stored, both for 'in project' use and sharing amongst Programs and upon maturity of the data and the long-term storage in approved data repositories.

#### What is not a PDS?

- Based on an issue of limited interest to producers in the area or an issue that contributes only very marginal improvement in enterprise business performance.
- Basic or applied research regarding a problem/issue (i.e. the solution is not yet known)
- Demonstration of how commercial technologies operate and perform. Demonstrations
  involving commercial technologies must focus on the business/decision-making value of the
  technology, not whether it works.
- Demonstrations not at commercial scale.
- A project where the facilitator does all the work, including taking in-field measurements, etc.

# Who can apply?

Funding is available for groups of mixed farming producers to validate and demonstrate the business value of integrating new commercially available technologies and on-farm management practices into local production systems.

All contracts will be required to be with a company or other legal entity, excluding individuals/sole traders. For unincorporated producer groups, arrangements should be made for contracting through an affiliated company.

Where the intended contracted party is a Trustee (on behalf of a trust), MLA will require copies of ID for all Trustees and a copy of the Trust Deed.

The Tenderer must provide details of its current insurance policies and each proposed subcontractor and supplier as outlined in the preliminary and full applications.

#### What is funded?

Producer groups engaged in the MLA/GRDC Partnership PDS projects will be able to access up to \$100,000 per year for up to 40 months to a maximum value of \$360,000.

MLA/GRDC Partnership PDS projects require cash investment in the project, which is matched by the MLA Donor Company (MDC).

The funding split is outlined below, calculated on total project value

- 50% GRDC Contribution
- 30% cash contribution + access fee (calculated on contribution value)
- 20% MLA MDC + access fee (calculated on contribution value)

The MLA MDC program is self-funded and is not supported by industry levy funds. The program can only be offered if sufficient funding is raised within the program to support the management, administration, and delivery of MDC activities. For this reason, a project access fee is applied to all MDC-supported projects. The MDC access fee is currently 8% or 12% of the contribution value, depending on the type of investment partner. Industry levy-payer partner contributions incur an 8% fee for their co-funding access. Other partners pay 12%. The access fee is invoiced quarterly or annually. Refer to PDS MDC Cash-Flow Frequently Asked Questions (FAQ) for further detail on the process of investing in MLA/GRDC Partnership PDS projects.

MLA/GRDC PDS funding can be used for the following:

- Facilitator time and expenses (for example, reporting, coordination, group activity)
- Operational aspects of the demonstration (excluding capital items)
- Extension and communications activities
- Conducting and reporting of robust monitoring & evaluation plan

MLA/GRDC PDS funding cannot be used for the following:

- Purchase of capital items (applicants should investigate sponsorship, share or leasing arrangements)
- Items of significant private benefit, e.g. DNA testing of whole flocks
- Purchase of animals

- Fencing and infrastructure (including temporary)
- eID Tags

#### **Priority areas:**

MLA and GRDC seek industry-aligned proposals for the MLA/GRDC Partnership PDS program across the mixed farming regions of Australia (see MLA/GRDC Partnership PDS Guidelines for map of regions)

MLA/GRDC Partnership PDS priorities for the mixed farming systems of Australia across Qld, NSW, ACT, VIC, SA, TAS and Southern WA are outlined below:

- 1. Optimise pasture and grain crop productivity through best management of plant nutrition and soils and enhanced biosecurity, weed, pest and disease control to improve profitability.
- 2. Sustainable, responsible production systems adapted to climate variability through business planning, enterprise mix, and risk management strategies. Demonstrating employment of commercial technologies, such as remote monitoring, virtual fencing, and drones, to increase efficiency and address labour shortfalls.
- 3. Demonstration of value-add opportunities in mixed farming systems to increase margins and/or lower post-farm gate costs.
- 4. Whole of landscape resource planning (e.g., water, land use, biodiversity) for the enhancement of livestock and grain crop production.

# Preparing and submitting an application

Applicants should follow these steps:

- 1. Establish or nominate a current producer group supported by a facilitator (may be a partnership with an organisation with a common purpose). All groups must include a person experienced in facilitation, communication and MER of on-farm projects.
- 2. Define and describe what the PDS project intends to achieve. This should include the following:
  - a. What is the practical problem or need that the group aims to address?
  - b. What is the current level of adoption of the targeted management practice(s)?
  - c. How will the targeted management practices improve business profitability and productivity, i.e. what will the project's outcome be?
  - d. What is the potential scale of benefit to businesses?
- 3. Identify the area/sub region covered by the PDS group the facilitator and the producer Chair.
- Submit a Preliminary Application (max 5 pages) outlining your proposed project. The Preliminary Application must be submitted on or before 03 October 2025.

- All preliminary applicants will be notified of acceptance or otherwise by 31 October 2025. If
  your Preliminary Application has been accepted, you will then need to prepare a Full
  Application using the PDS Full Application forms and submit it to <a href="mailto:pds@mla.com.au">pds@mla.com.au</a> by 21
  November 2025.

- 6. If your PDS is to be contracted through a supporting agency, e.g. DPI or Landcare group, submit your PDS application to the management of the participating supporting agency before submitting it to MLA for review and endorsement.
- 7. All successful applicants will be notified by 19 December 2025.
- 8. Projects will be contracted and ready to commence by early 2026.

#### Important information regarding the tender process:

- 1. Tenders must comply with all requirements specified in this request for tender/terms of reference.
- 2. The requirements specified in this request for tender apply to both the preliminary and full applications.
- 3. Please submit an electronic/soft copy of the tender/applications.
- 4. All questions within the preliminary application form must be completed. Where invited to submit a full application, the current version of the Full Application Form must be completed in its entirety.
- 5. Tenderers of successful full applications will be provided with a link to complete a questionnaire regarding modern slavery due diligence. Completion of the questionnaire is required before progressing with contracting.
- 6. MLA has been appointed "Manager" of the Program and, as such, will be the key contact for the delivery partners associated with each Project and will be responsible for contracting, communications and financial payments.
- 7. The Terms of Agreement MLA wishes to enter with the successful Tenderer may be requested by emailing <a href="mailto:pds@mla.com.au">pds@mla.com.au</a>. MLA is non-negotiable on the terms of the agreement.
- 8. Where the successful Tenderer has a negotiated standard agreement with MLA, the terms of that agreement will apply. Where no previously negotiated agreement is in place unless

- clearly stated to the contrary in the tender, all terms of our MLA Umbrella Research Agreement will apply.

#### Selection criteria & review process

Selection of preliminary applications and full applications will be based on the following criteria

- 1. Alignment with priorities outlined in the terms of reference.
- 2. Number and enthusiasm of producers in the core group and opportunity for broader scale engagement across the observer group/district
- 3. Potential impact on producer business profit drivers & industry profitability
- 4. Project team's capability to undertake the requirements of a PDS
- 5. A very clear and measurable objective(s)
- 6. Methodology to demonstrate the business value of the technology/practice/innovation(s) and achieve practice change.
- 7. Extension and communications plan and activities within the PDS group (core) and more broadly (observer group and nationally)
- 8. Proposed monitoring, evaluation, and reporting (MER) activities and data management plan
- 9. Value for money

Applications that demonstrate cash and in-kind producer support and sponsorship for capital items will be viewed favourably.

#### **Application Review:**

Three regional joint evaluation committees (Northern, Southern & Western) will be established to review, assess, and determine successful projects at the preliminary stage.

The preliminary application evaluation committee will be comprised of six members:

- o 1 x GRDC staff
- o 2 x GRDC Regional Panel members per region (Northern, Southern & Western)
- o 1 x MLA Adoption Project Manager
- 2 x MLA Research Advisory Committees producer members per region (NABRC, SALRC and WALRC).

An evaluation committee will also be established to review, assess, and determine successful projects at the full application stage.

The full application evaluation committee will be comprised of six members:

- o 2 x GRDC staff
- o 2 x MLA Adoption Project Manager

#### Additional commitments

- Projects may be required to nominate a producer case study(s) for MLA/GRDC communication activities
- Producers involved in projects may be required to participate in impact evaluation surveys in future years, including post-project completion.
- Successful applicants will be required to participate in MER training before the commencement of the project.
- Projects will be required to robustly estimate the potential scale of adoption beyond the core
  group and the potential benefits to individual producers and industry as part of their MER
  plan.
