



Training Reimbursement Program

Receive up to \$700 back when you attend an eligible training event

Fitzroy Basin Association (FBA) believes that the continued growth and development of landholder skills and knowledge is an important part of achieving long-term sustainability of our grazing and cropping industries. Reimbursement is offered to landholders who participate in eligible training events and audits.

Am I eligible?

To be eligible for reimbursement you must own or manage a grazing or cropping property within the Fitzroy NRM region.

What training is eligible?

There are several training events and market certification systems that positively build on the capacity of producers. For this reason, the eligibility for reimbursement remains at the discretion of FBA and each application will be assessed on a case by case basis. Training events eligible for reimbursement must develop attendee's knowledge and skills in one or more of the following areas:

- ✓ Grazing land management, land capability and/or property mapping
- ✓ Business planning, analysis, benchmarking and/or development
- ✓ Livestock marketing, reproduction, genetics and/or nutrition
- ✓ Crop layout, GPS technology, contour design and/or precision farming
- ✓ Animal health and welfare, drought planning and/or biosecurity
- ✓ People management, WHS, succession and/or human resources
- ✓ Soil health, gullies and erosion, ecology and/or hydrology
- ✓ Chemical, fertilizer and/or herbicide use and storage

* Market based certification audits eligible for reimbursement include (but are not limited to): Pasturefed Cattle Assurance System (PCAS), Australian Certified Organic, Livestock Production Assurance (LPA) and Global Animal Partnership (GAP).

How much is reimbursed?

Through funding from the Queensland Government, FBA is offering to reimburse up to 70% of the cost of training or audit, capped at \$700 per financial year, per business.
