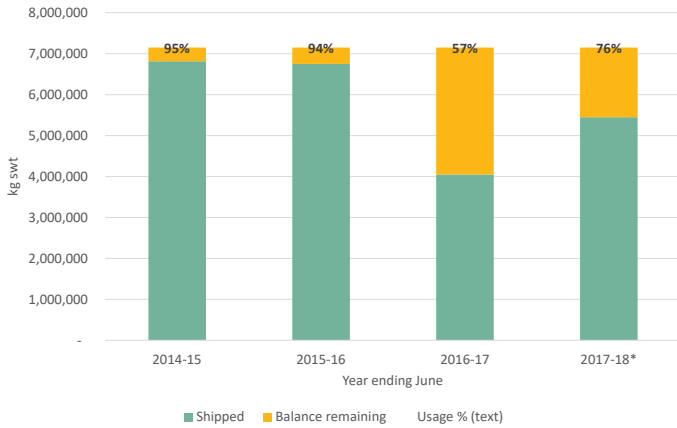

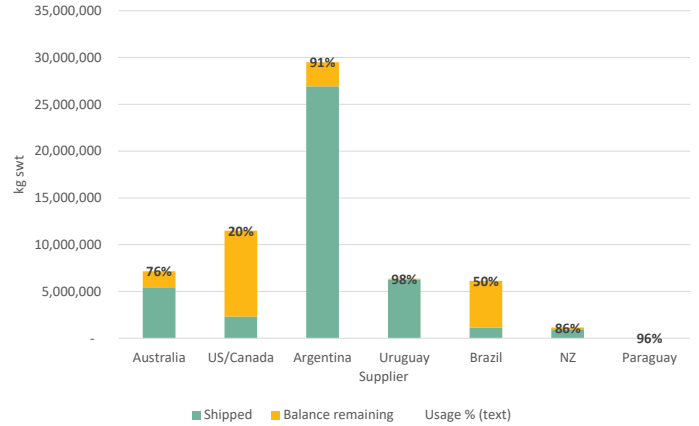
This report monitors quotas and safeguards in key Australian red meat export markets. Please take note that sources and time periods vary depending on importing country and quota administration.

Australia-EU Hilton HQB quota\*

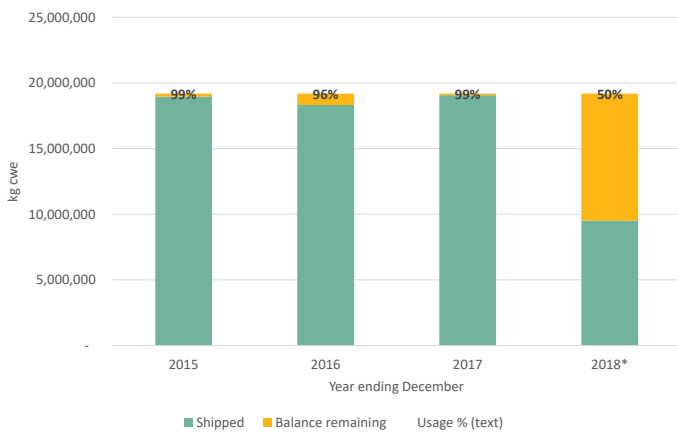


EU Hilton HQB quotas | 2017-18\*

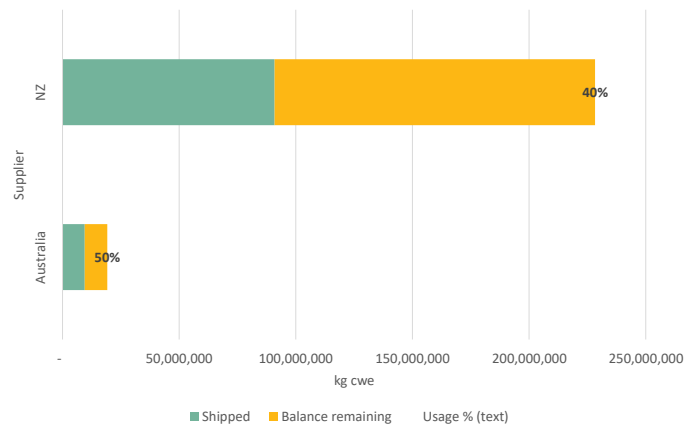

Australia-EU sheepmeat quota\*\*

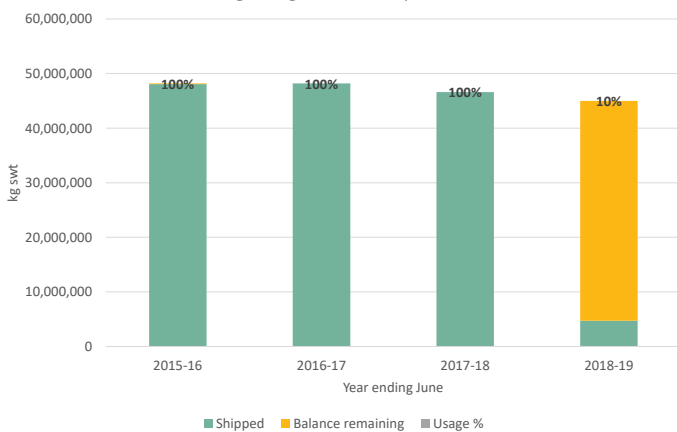


EU sheepmeat quotas | 2018\*\*

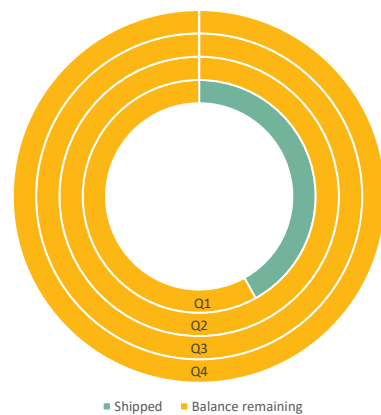

Quarterly EU grainfed beef quota usage | 2018-19\*\*\*

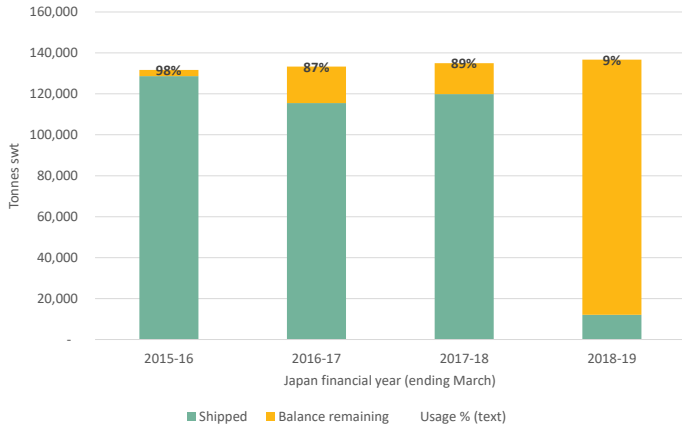

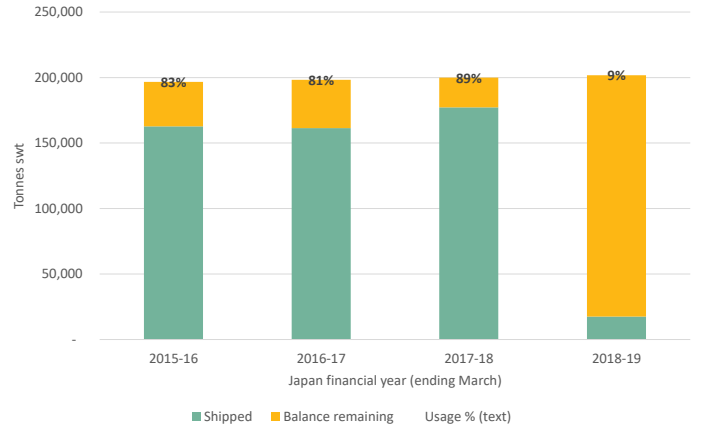

Australia-Japan (JAEPA) chilled beef safeguard<sup>††</sup>

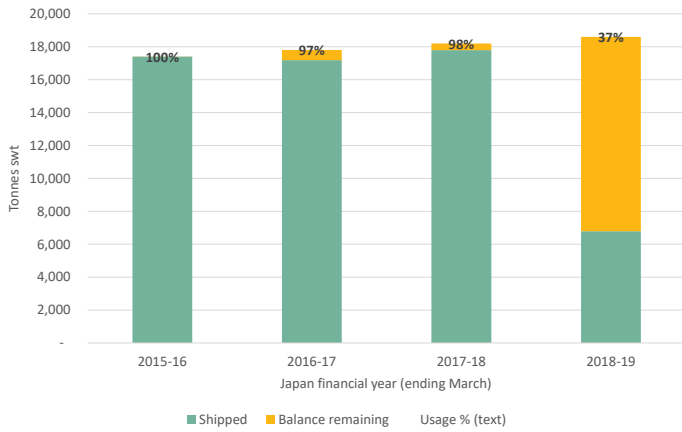


Australia-Japan (JAEPA) frozen beef safeguard<sup>††</sup>

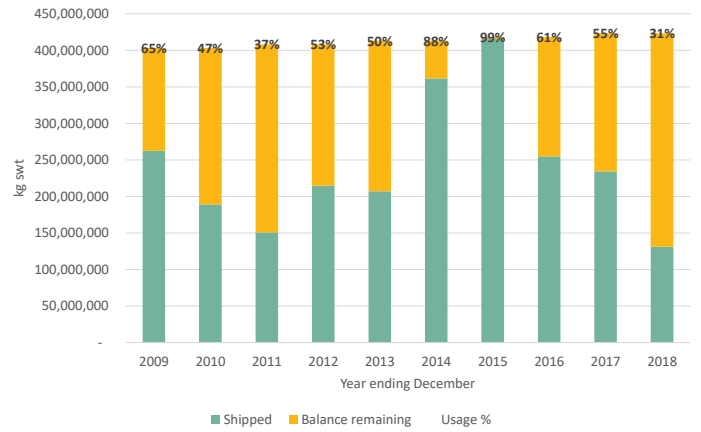

Australia-Japan (JAEPA) beef offal quota\*



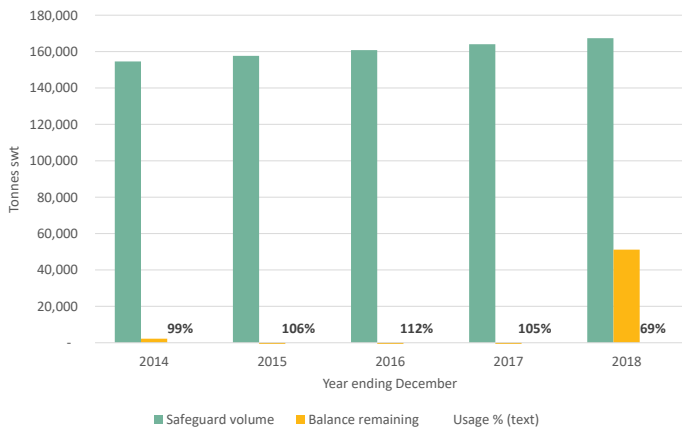
Australia-US (AUSFTA) beef quota\*



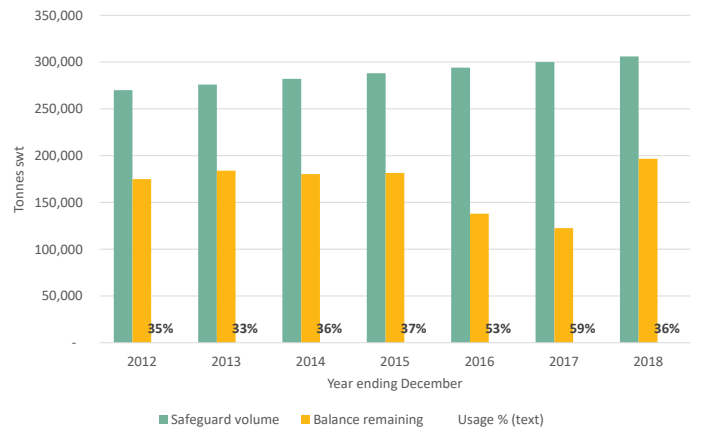

Australia-Korea (KAFTA) beef safeguard<sup>†††</sup>

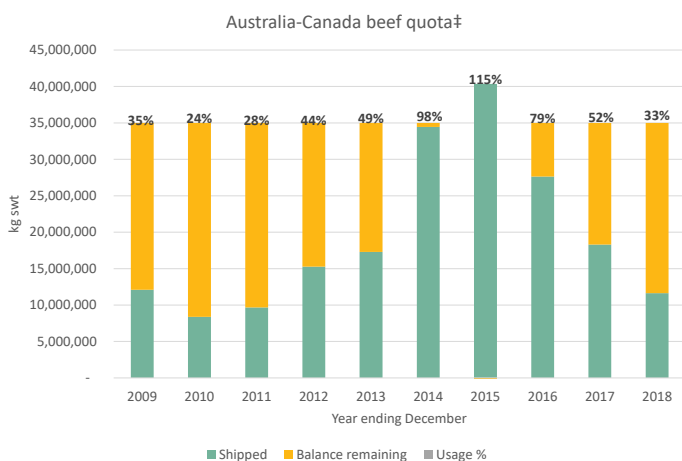


US-Korea (KORUS) beef safeguard<sup>†††</sup>



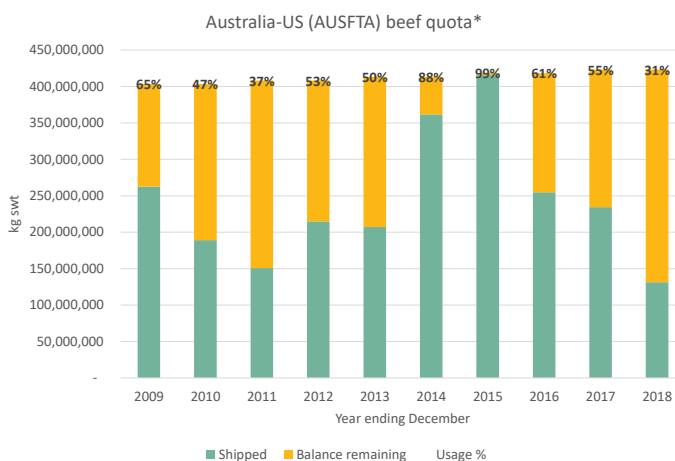

Under the Thailand-Australia Free Trade Agreement (TAFTA) Australia has access to a 1,463 tonne safeguard in 2018. However this safeguard is not included in this report as it is usually filled in the first two weeks of the calendar year. The safeguard is due to be phased out by 2020.
