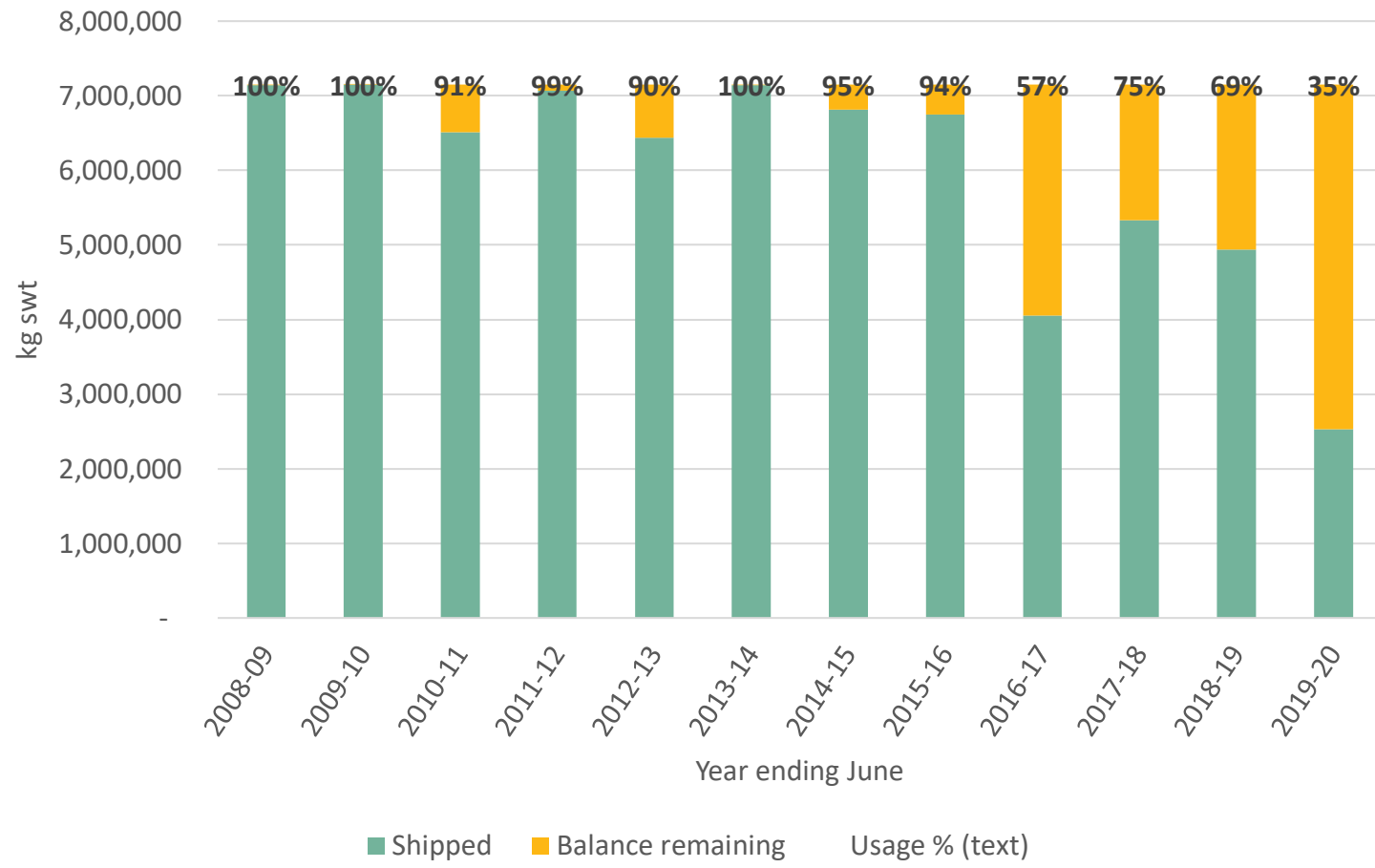

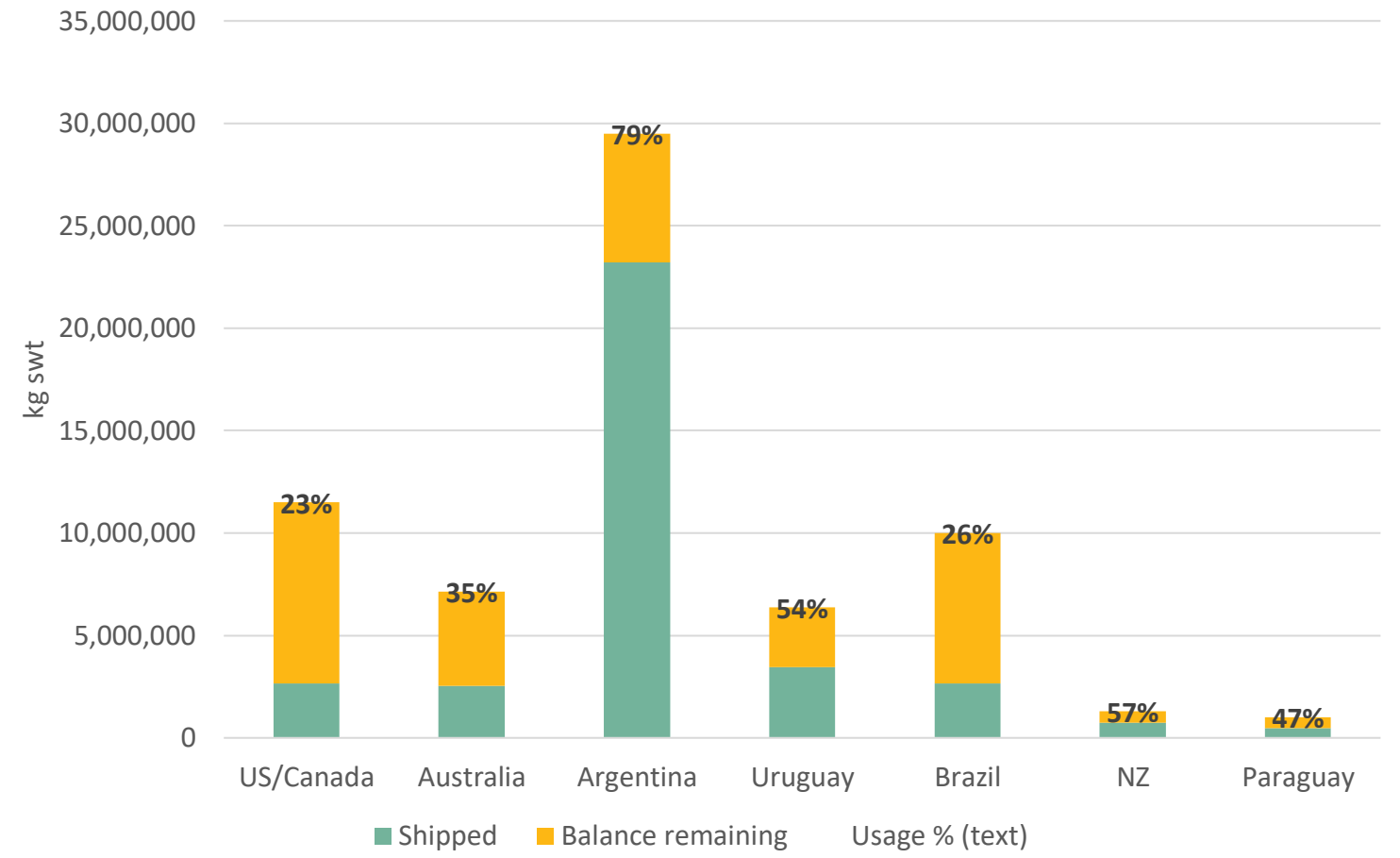

EU Hilton HQB quotas | 2019-20

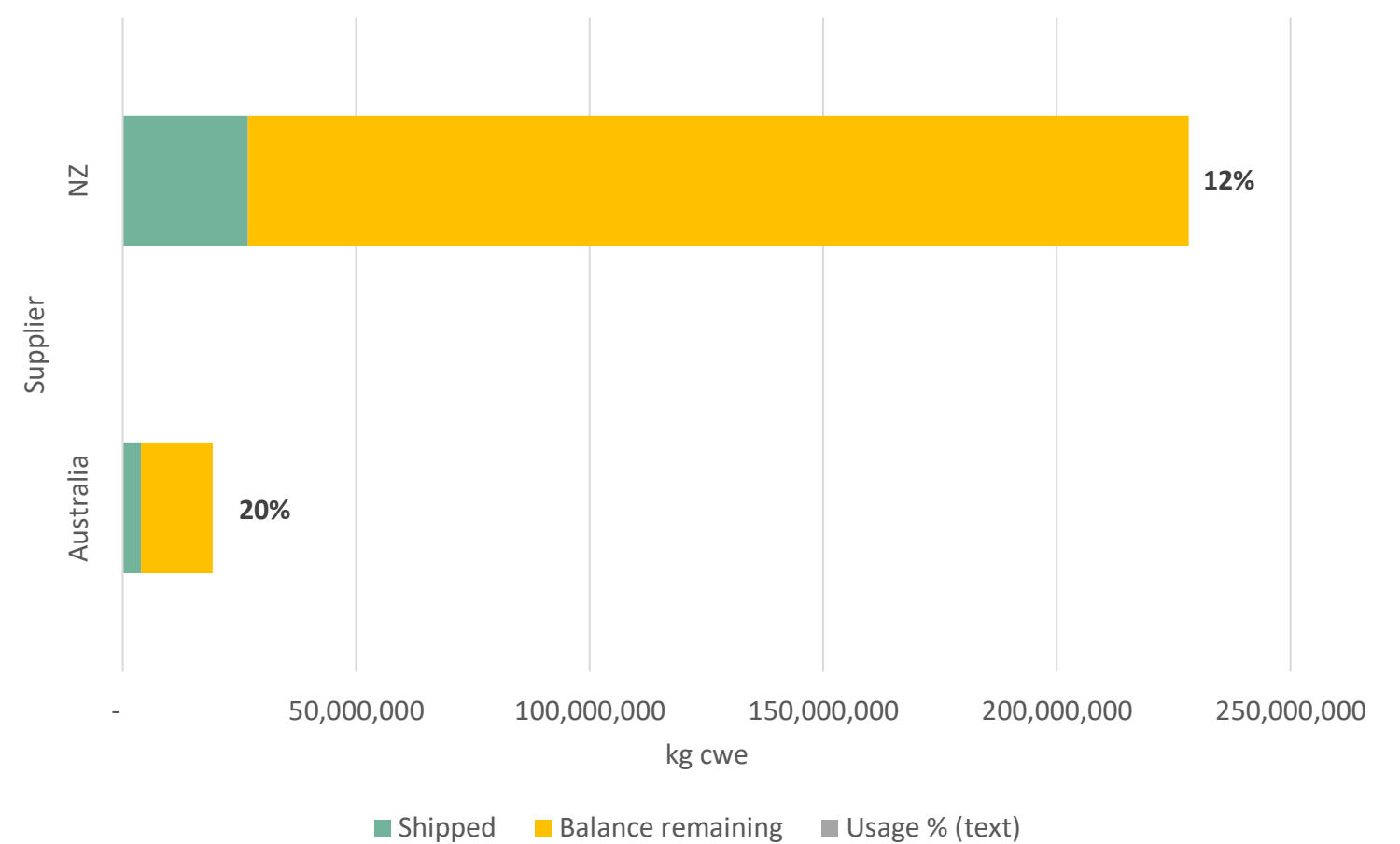


Australia-EU sheepmeat quota

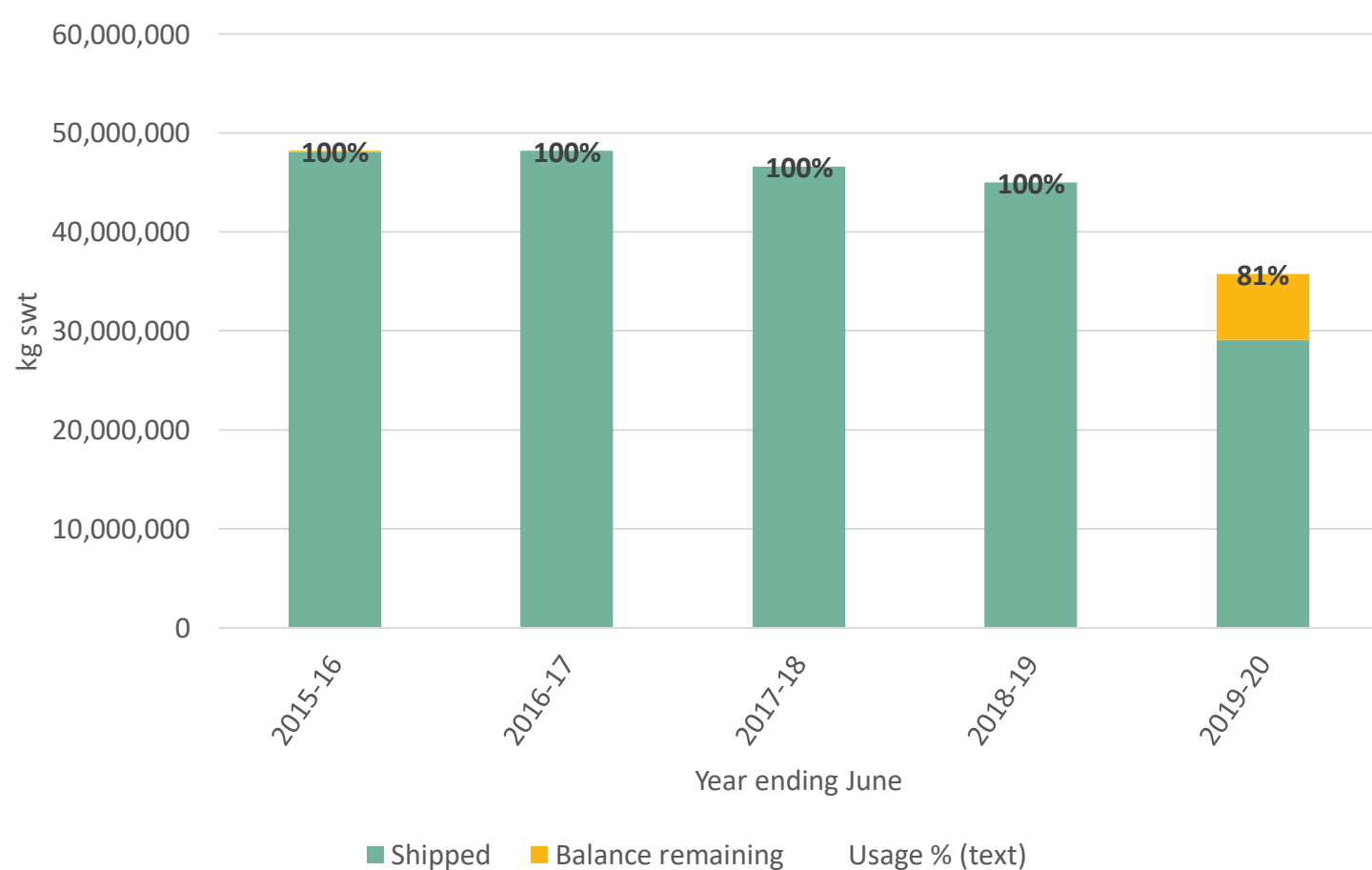

EU sheepmeat quotas | 2020



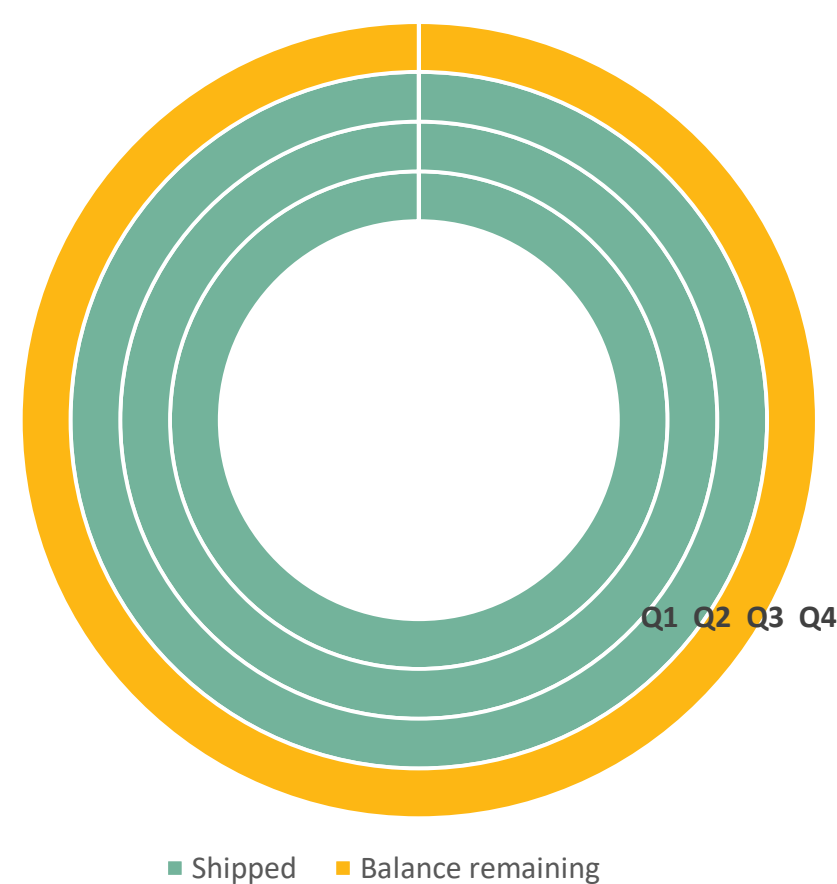
EU global grainfed beef quota

Quarterly EU grainfed beef quota usage | 2019-20

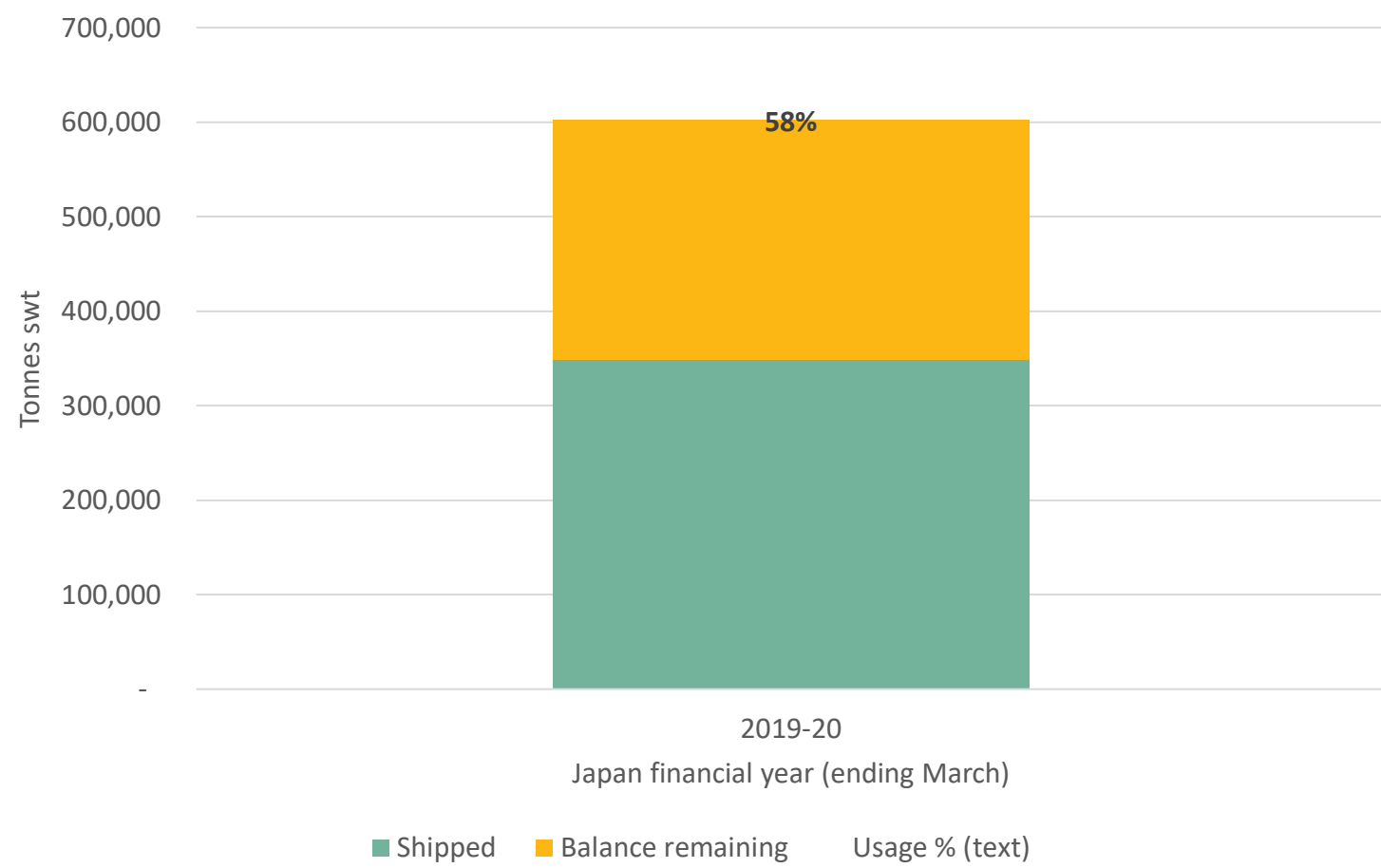

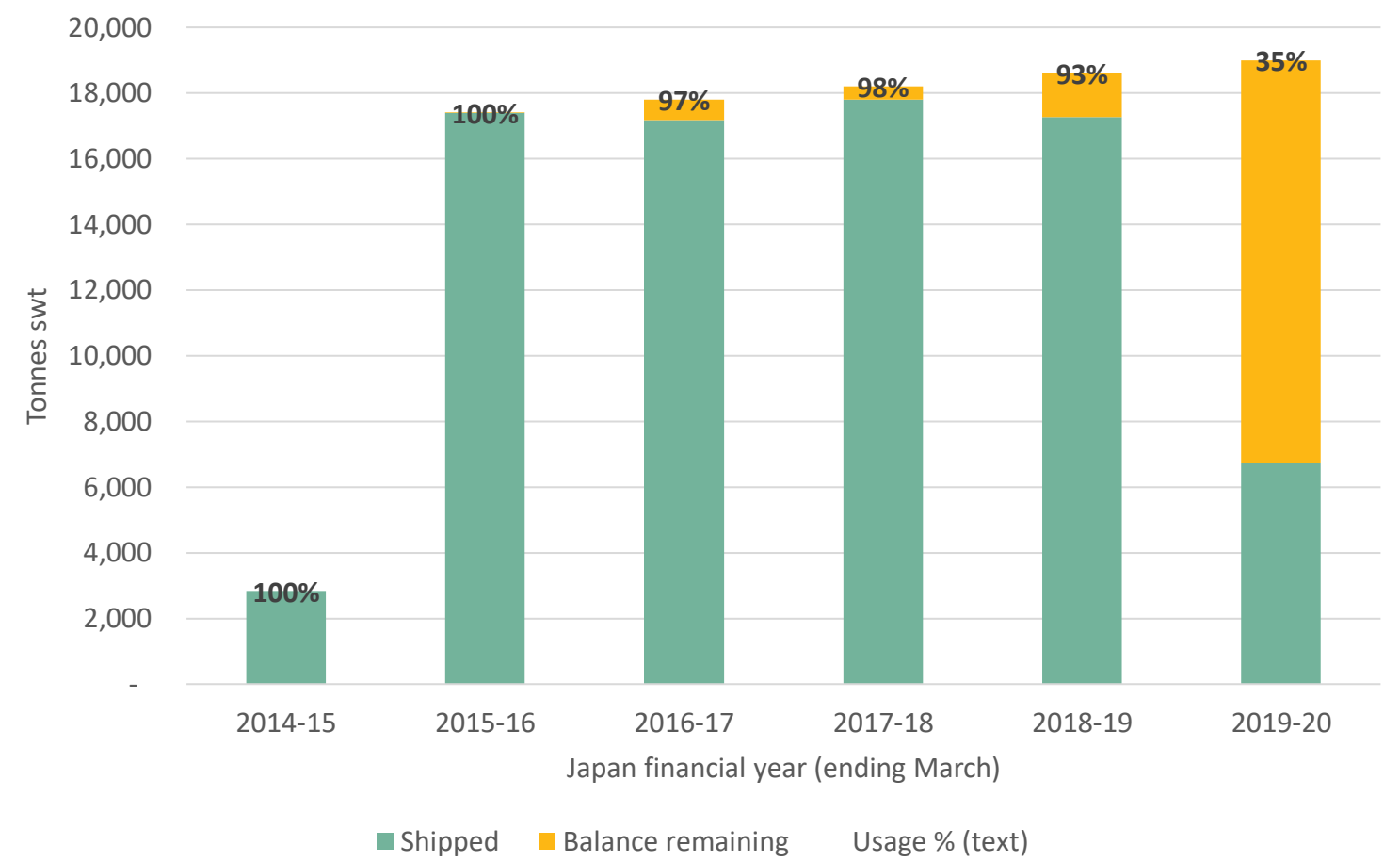

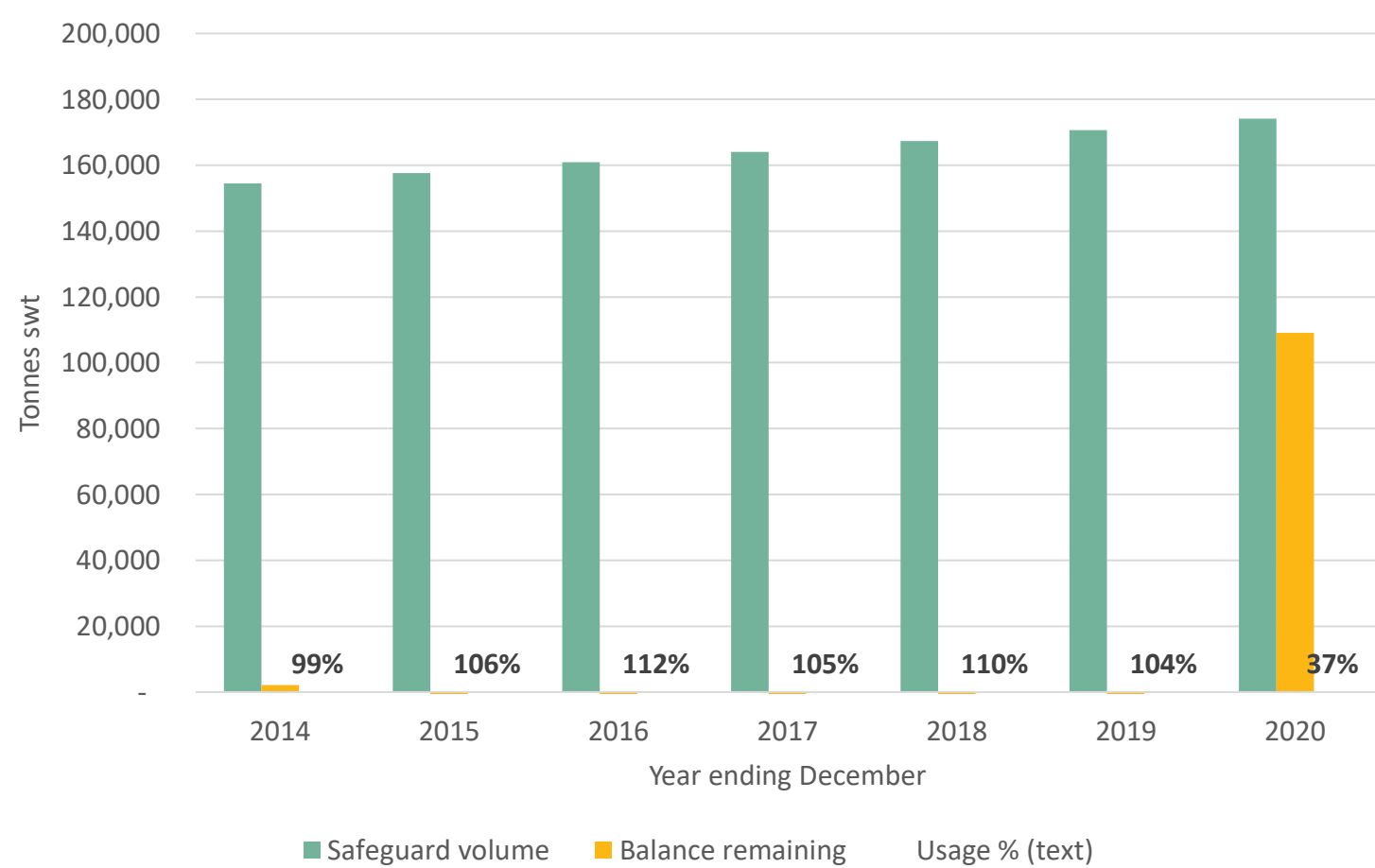
Australia-Japan (JAEPA) beef offal quota

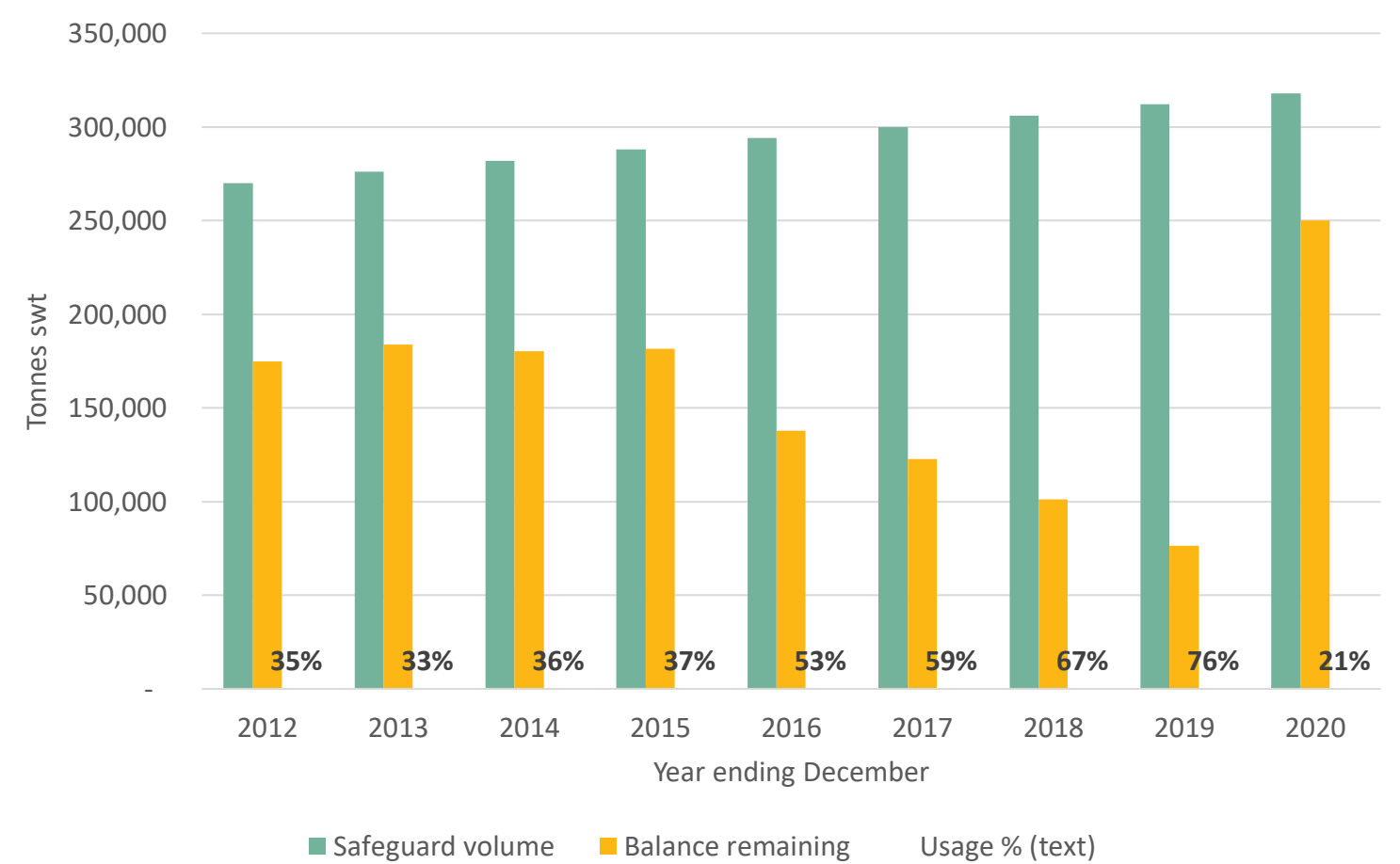

Australia-Korea (KAFTA) beef safeguard



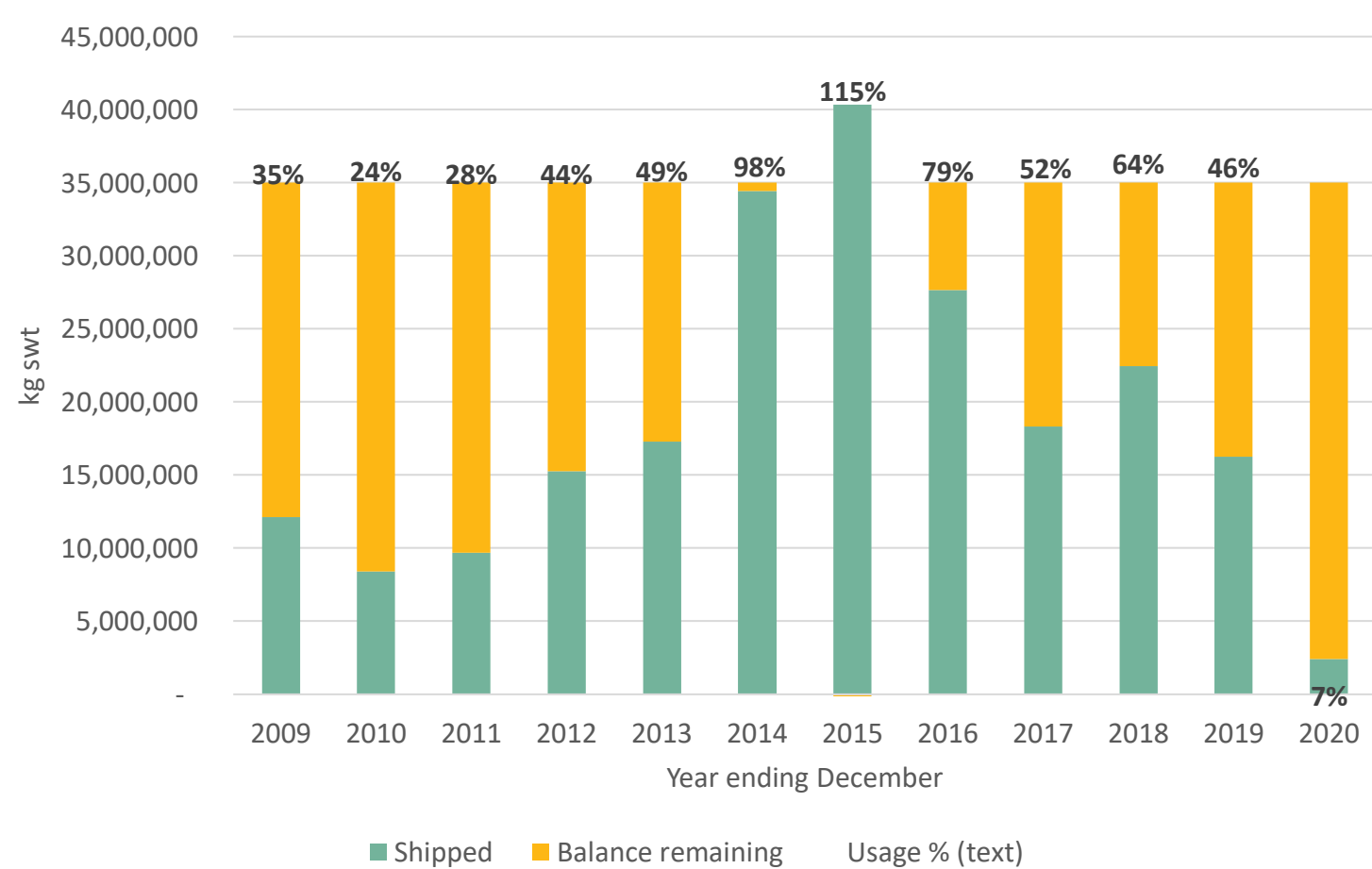

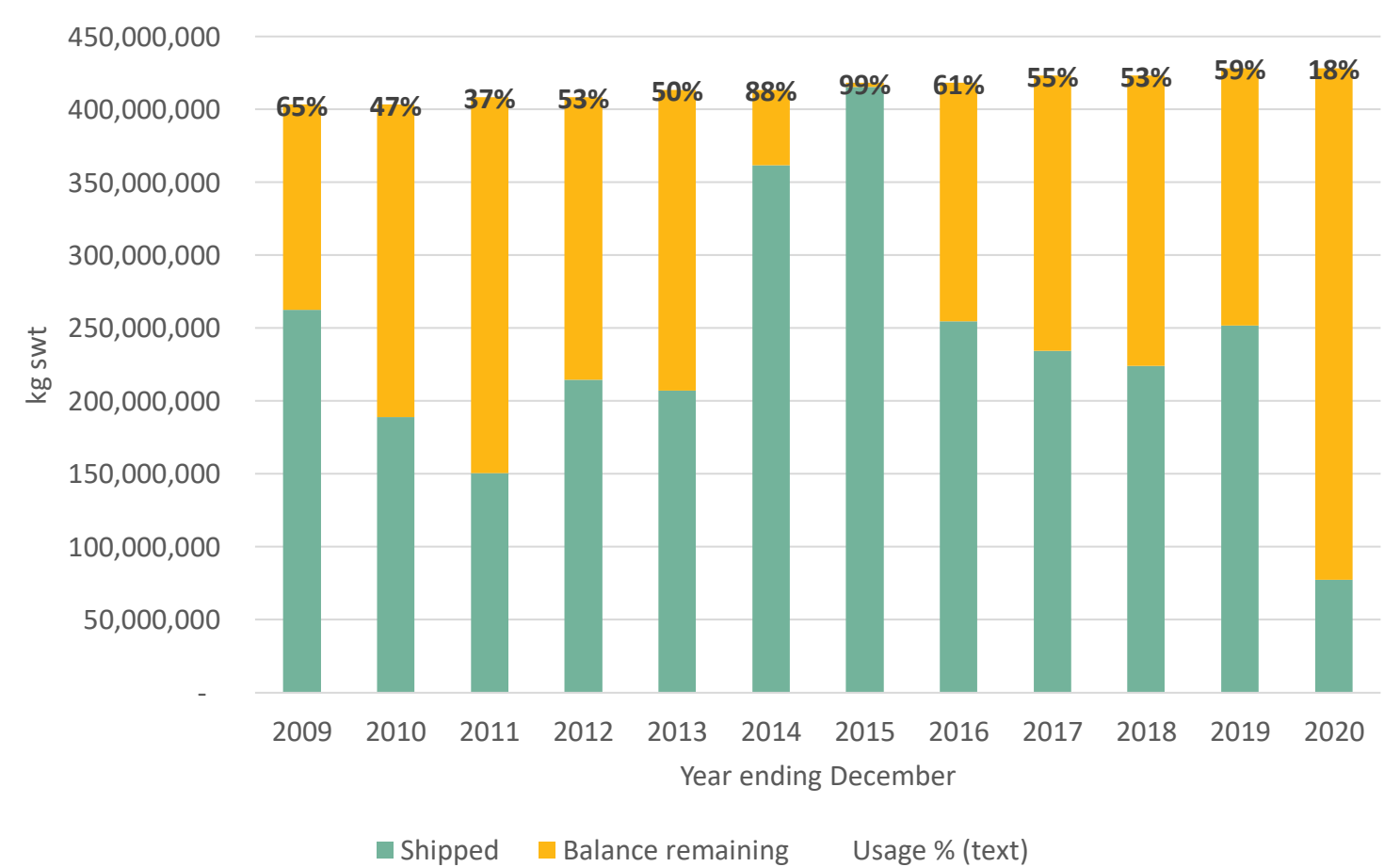

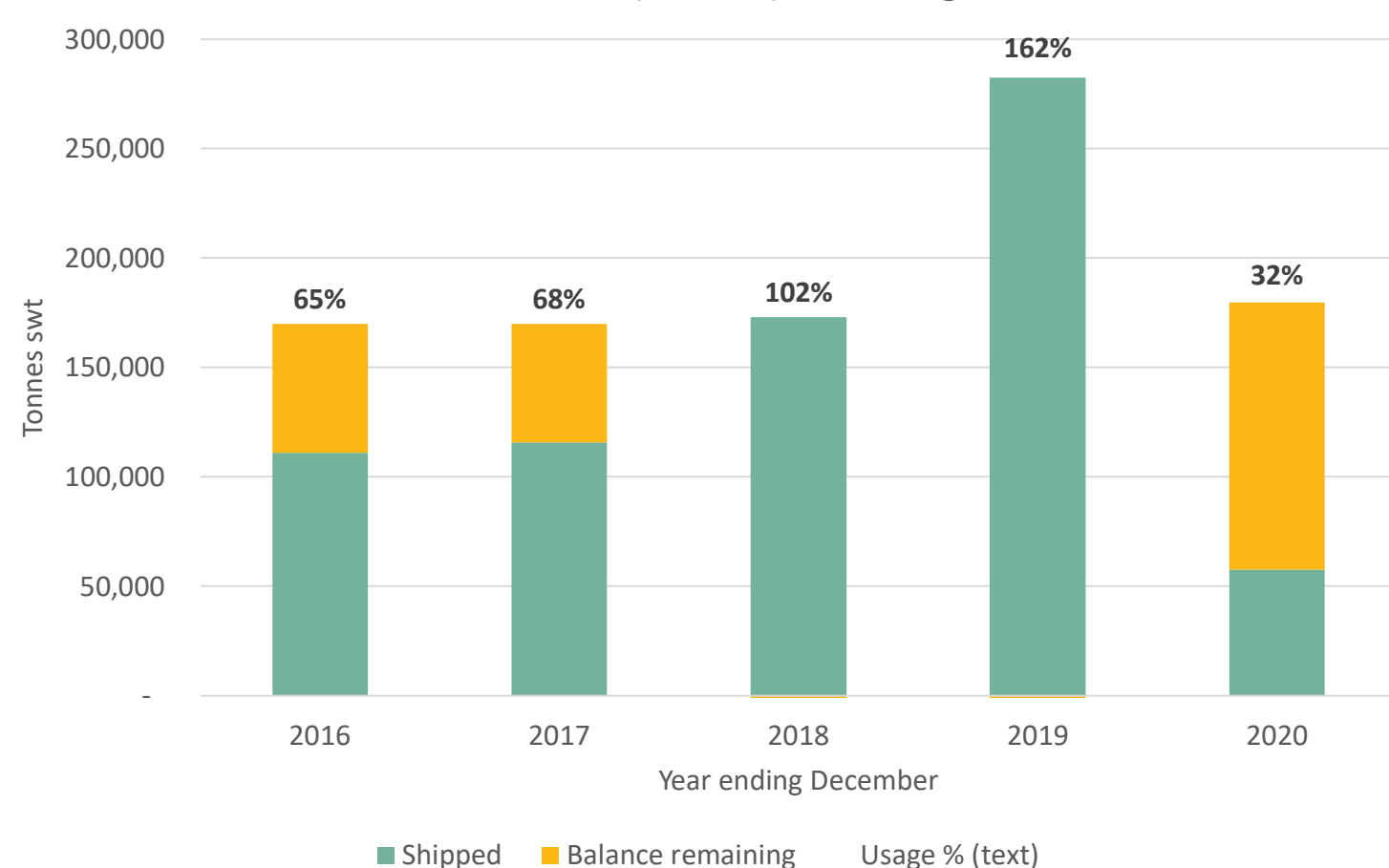
Australia-US (AUSFTA) beef quota

Under the Thailand-Australia Free Trade Agreement (TAFTA) Australia has access to a 1,463 tonne safeguard in 2018. However this safeguard is not included in this report as it is usually filled in the first two weeks of the calendar year. The safeguard is due to be phased out by 2020.
