1. Purpose:

Meat & Livestock Australia and the National Livestock Genetics Consortium are seeking expressions of interest from individuals within a northern pastoral company with extensive professional experience in composite beef breeding.

2. Relevant and necessary background

The National Livestock Genetics Consortium (NLGC) was established in October 2016 and is governed by a skills based taskforce (Taskforce). The NLGC provides direction and support to increase collaboration, transparency, communication and investment in livestock genetics research, development and adoption (RD&A) in Australia. The primary aim of this initiative is to significantly increase the rate of genetic progress achieved in the sheep and beef industries. The NLGC functions as a collaborative co-investment vehicle for new investments in genetics and genomic RD&A that utilises MLA and MLA Donor Company (MDC) governance structures to engage and oversee projects.

The aims of the NLGC are:

- To double the annual rate of improvement in industry genetic value by 2022.
- To coordinate research, reduce timelines and costs ensuring delivery of world leading genetic improvement.
- The seamless transfer of information to industry and provision of easy-to-use data sharing products and services through an accessible data platform.
- Improve adoption through unifying the delivery of genetic RD&A across the livestock industry.
- Deliver an additional \$400 million in industry improvements to the commercial livestock industry value chain.

- Cultural Change
- Disruptive Technologies
- National accessible data platform
- Collaboration

3. Terms of Reference

The NLGC Taskforce are seeking to find an individual to represent the Composite Beef Breeding sector who has extensive genetics and breeding experience. As well as having the skills to ensure investments through the NLGC will deliver greater impact for livestock producers and the red meat value chain.

The NLGC is currently seeking an individual with the following essential experience and skills:

- Current or preceding composite cattle breeder
- Knowledge and understanding of livestock genetics and breeding
- A proven track record in delivering high rates of genetic progress
- Involvement in utilising genetic and genomic tools in a composite cattle-breeding program
- Current representation and experience of pastoral companies

- Tertiary qualifications or equivalent industry experience in livestock production and/or genetics
- Involvement in strategic thinking and planning
- Background in the red meat sector.
